**Subject: Submission of proposals for release of 2<sup>nd</sup> instalment of Recurring Central Assistance under PM POSHAN - reg.**

Sir/Madam,

I am directed to say that 1st instalment for recurring central assistance under the PM POSHAN scheme has been released to most of the States & UTs for ensuring smooth implementation of the Scheme.

2. Upto 60% of the admissible recurring central assistance under the Scheme has been made available (first instalment + unspent balance) to the States and UTs who have submitted their proposals along with all supporting documents. The States and UTs who submitted incomplete proposals for 1<sup>st</sup> instalment, are requested to submit their proposals, complete in all respects, without any further loss of time.

3. Further, in this context, States and UTs are requested to submit proposals for release of 2<sup>nd</sup> instalment of recurring central assistance alongwith the following information on the component-wise expenditure statement in the format at Annexure. States and UTs are also required to confirm the following:

i) State has released the entire amount of Central share together with due State share from the State treasury to SNA Account, as prescribed by Department of Expenditure, Ministry of Finance.

ii) Funds available in the SNA account including State share at the time of release of funds are not more than the amount of Central share likely to be released.

iii) State has utilised at least 75% of the funds released (both Central share as well as corresponding State share).
