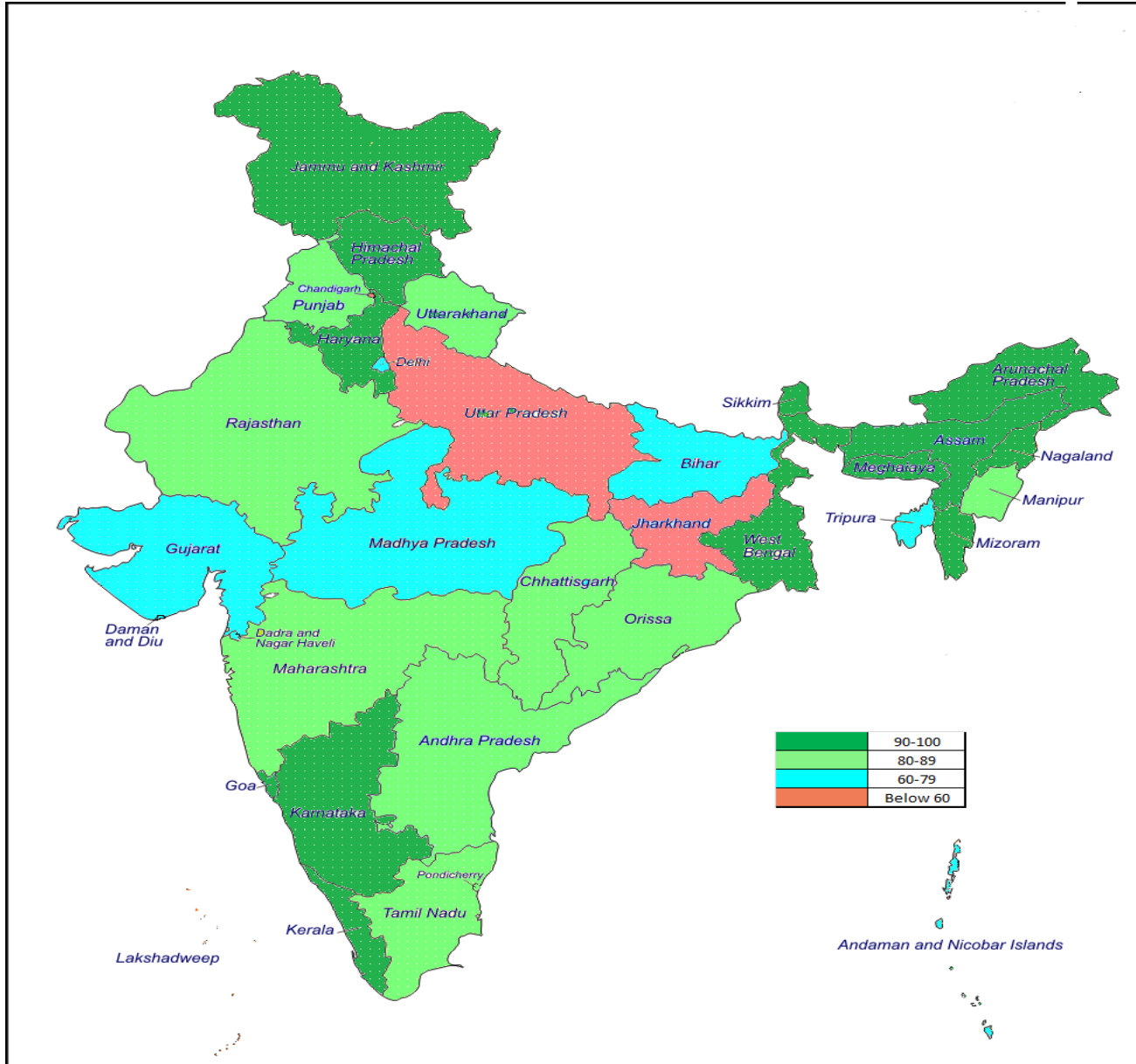

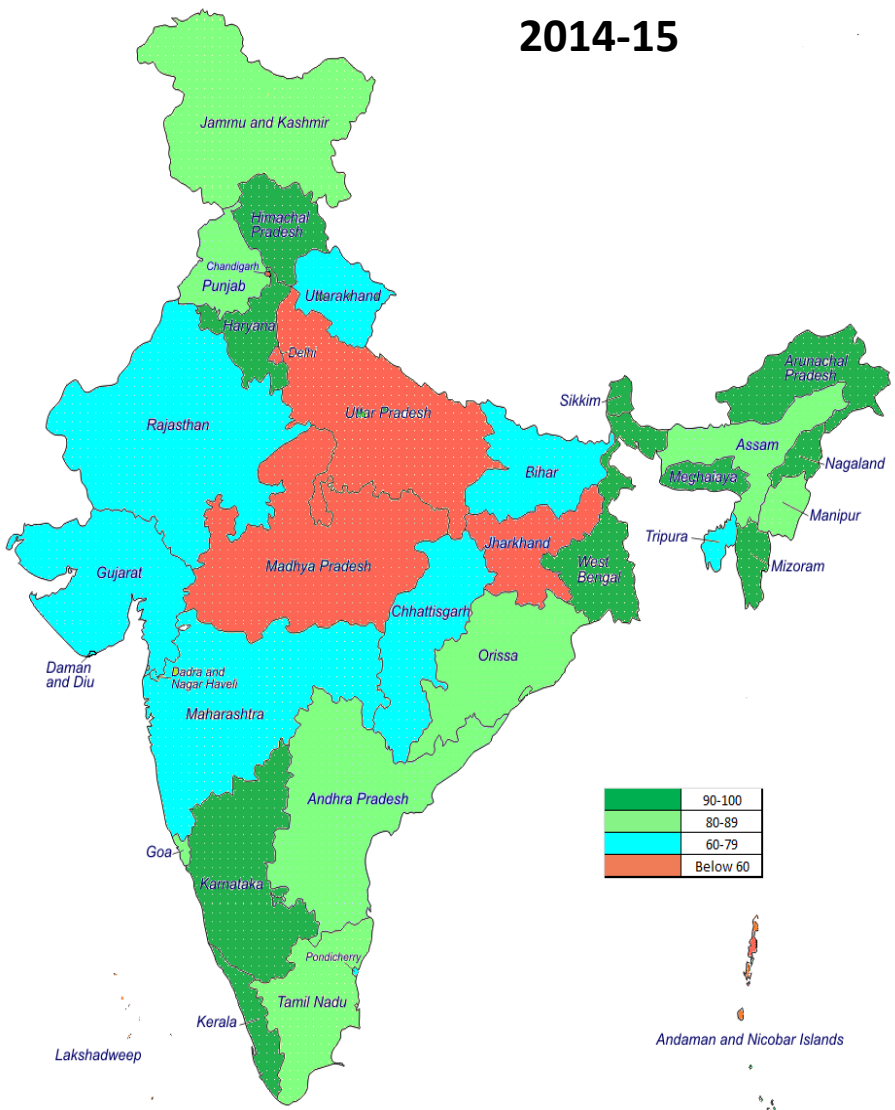
Coverage of Children against Enrolment 2013-14



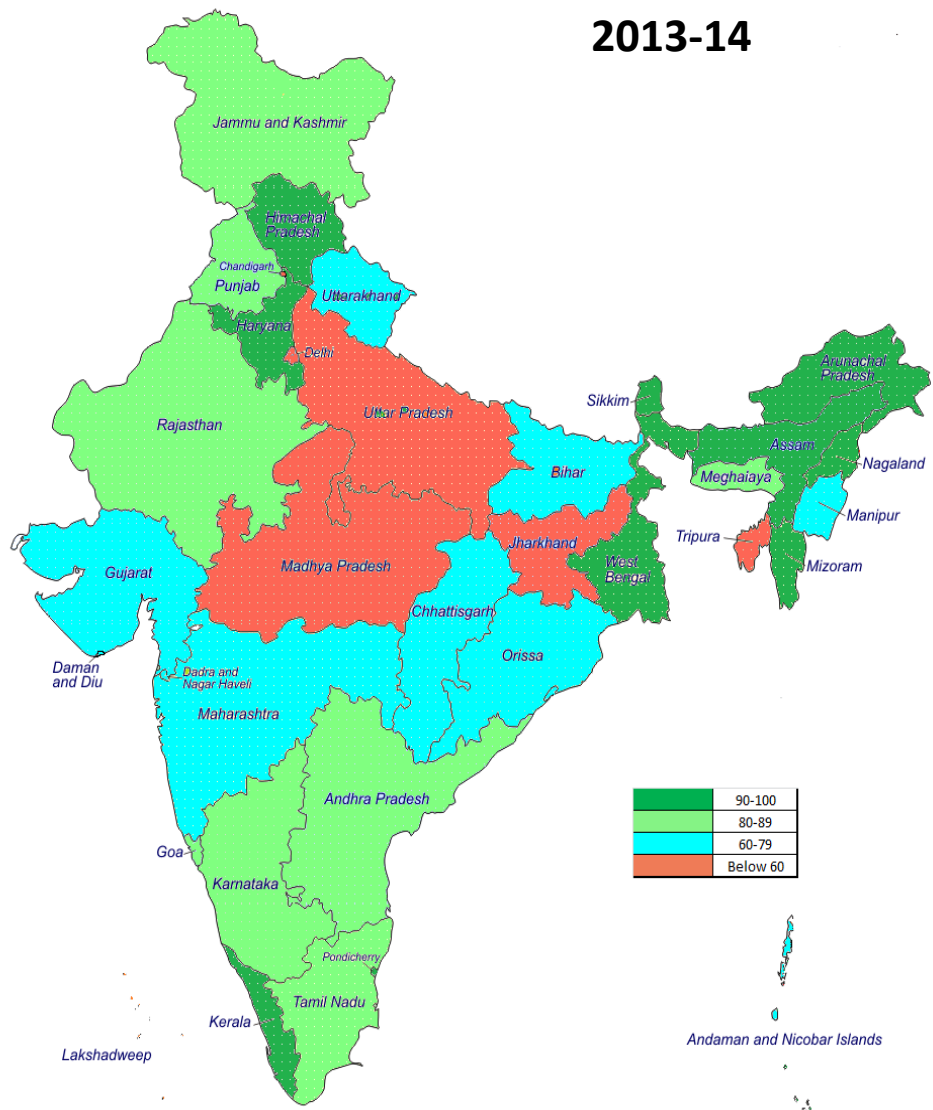
Coverage of Children against Enrolment (1st Qtr)



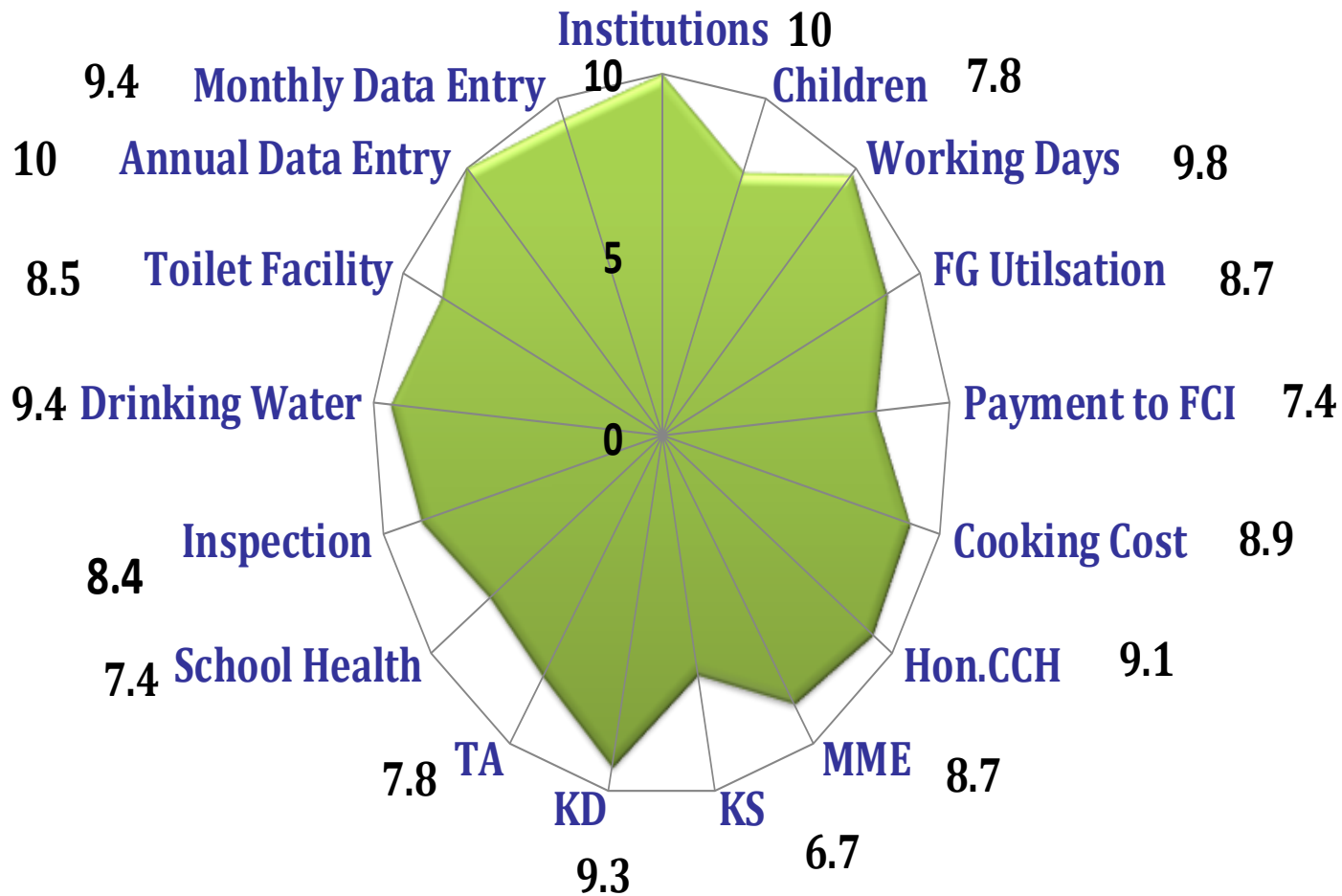

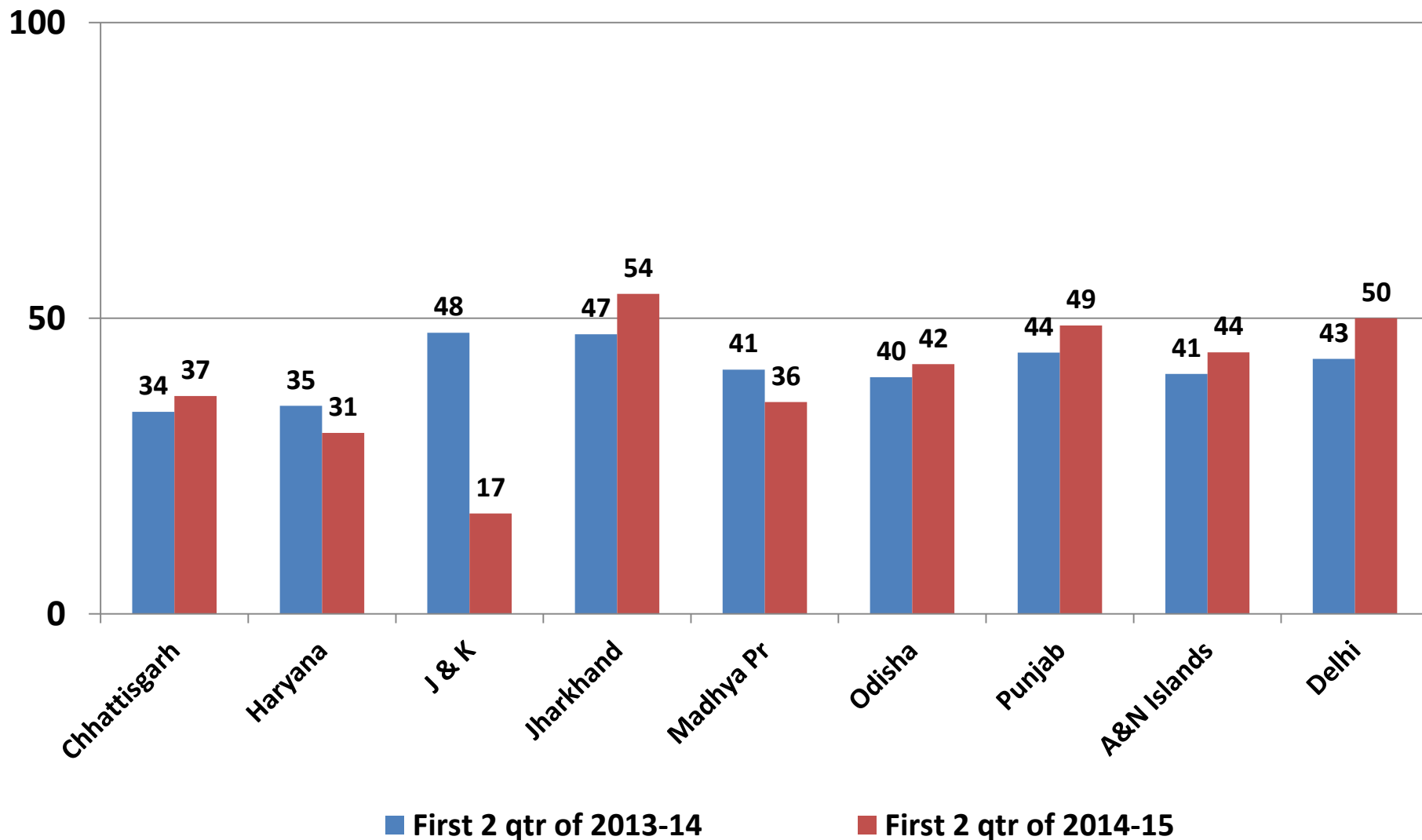
Coverage vis-à-vis PAB approval



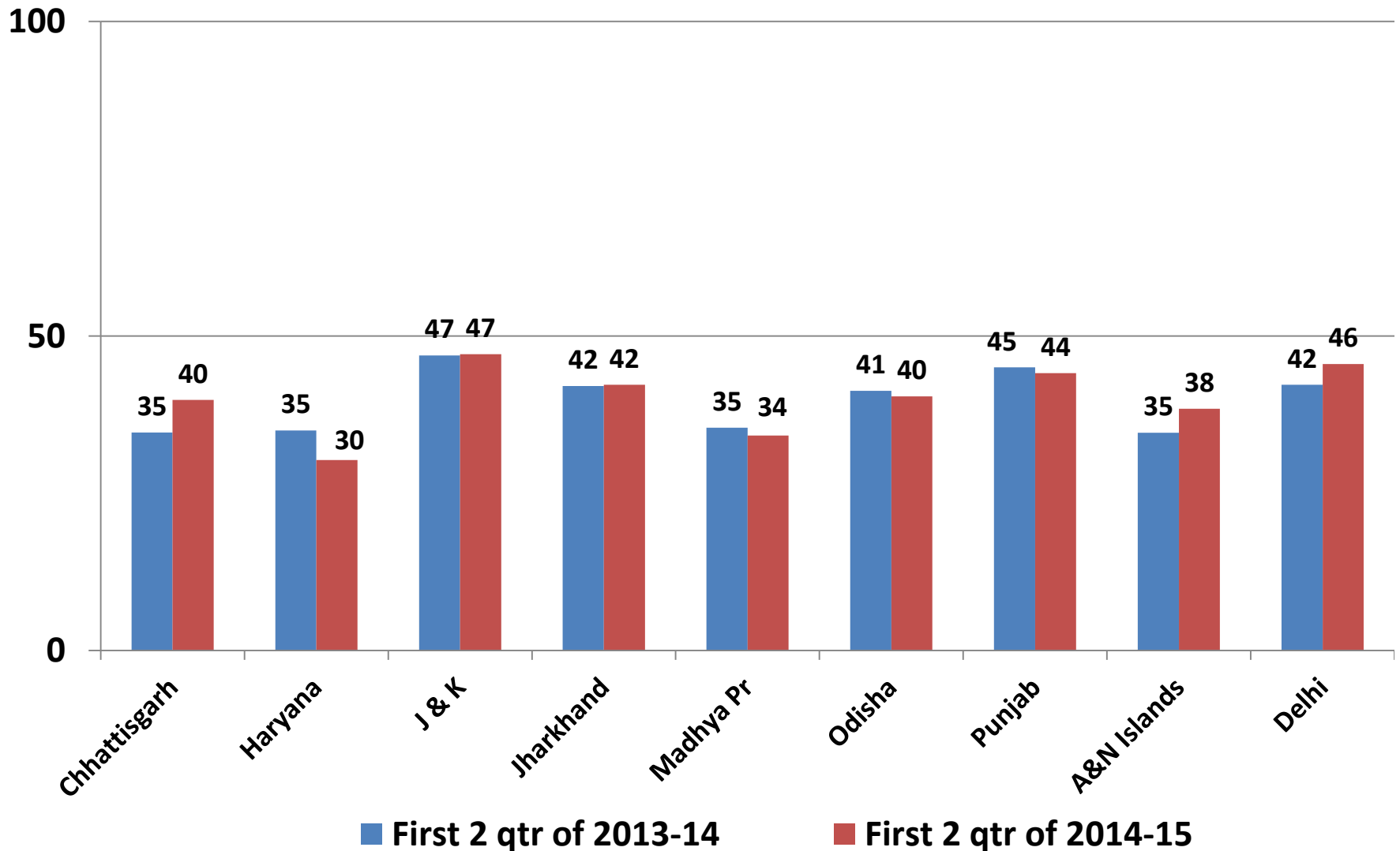

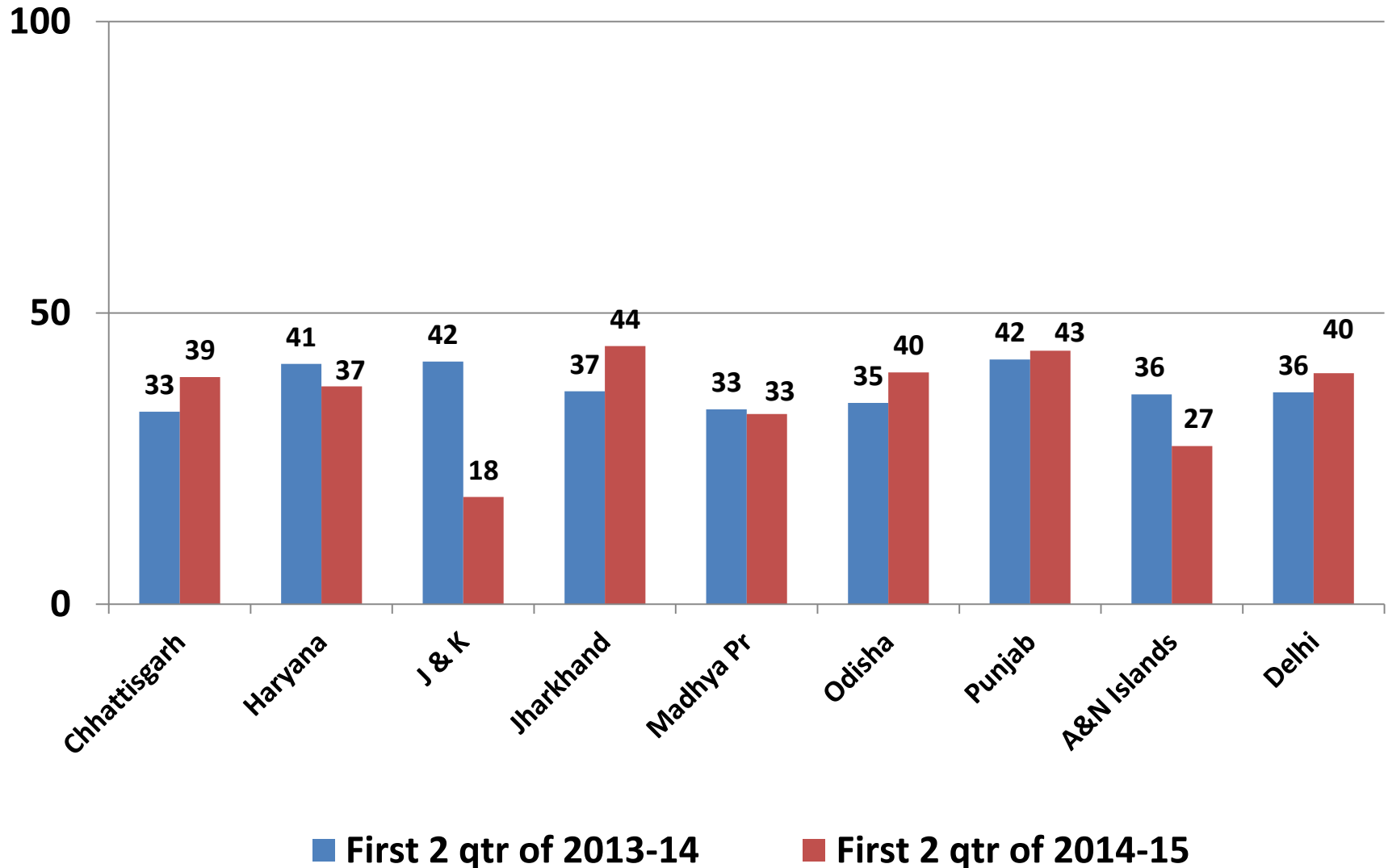
Food Grains Lifting



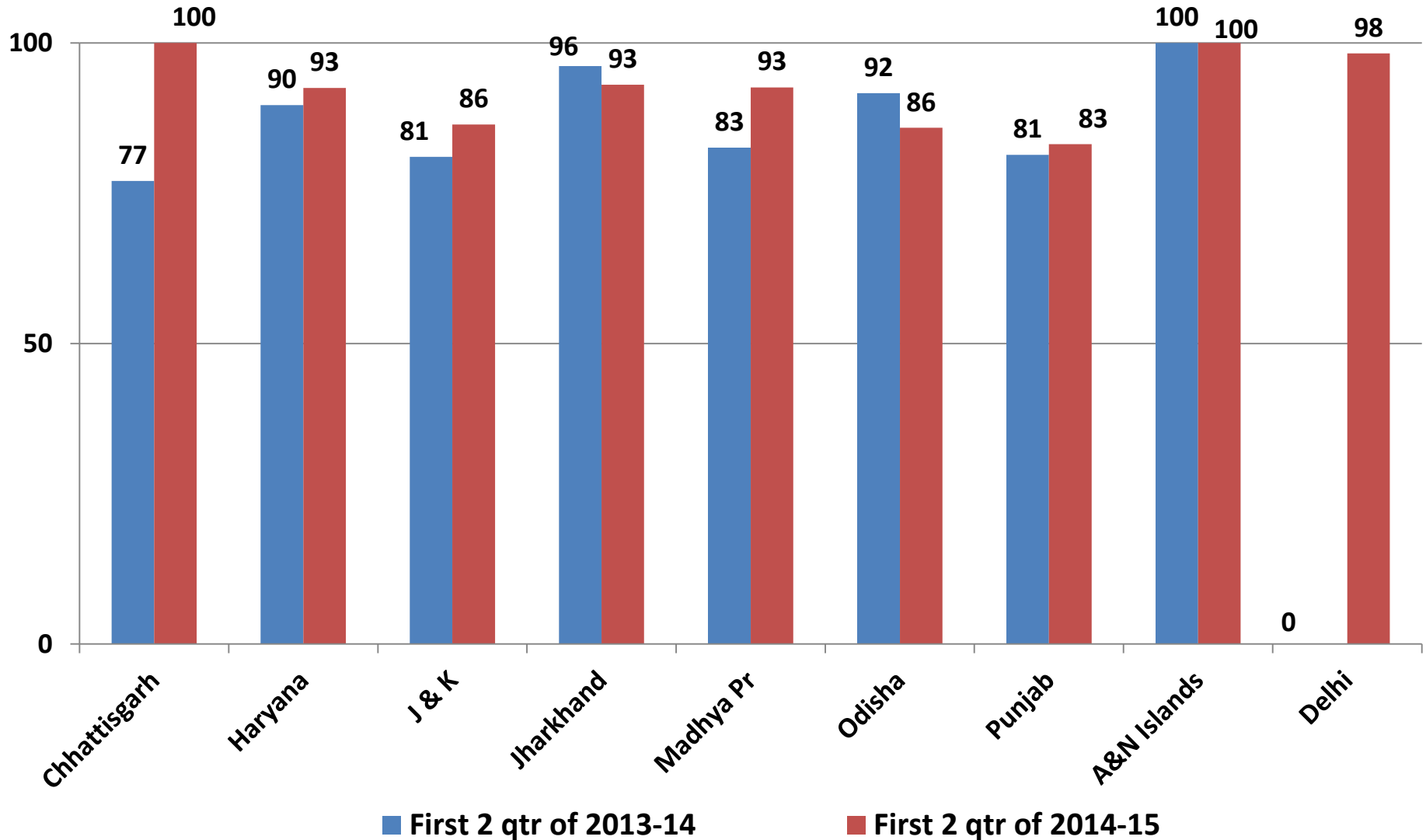
Food Grains Utilisation



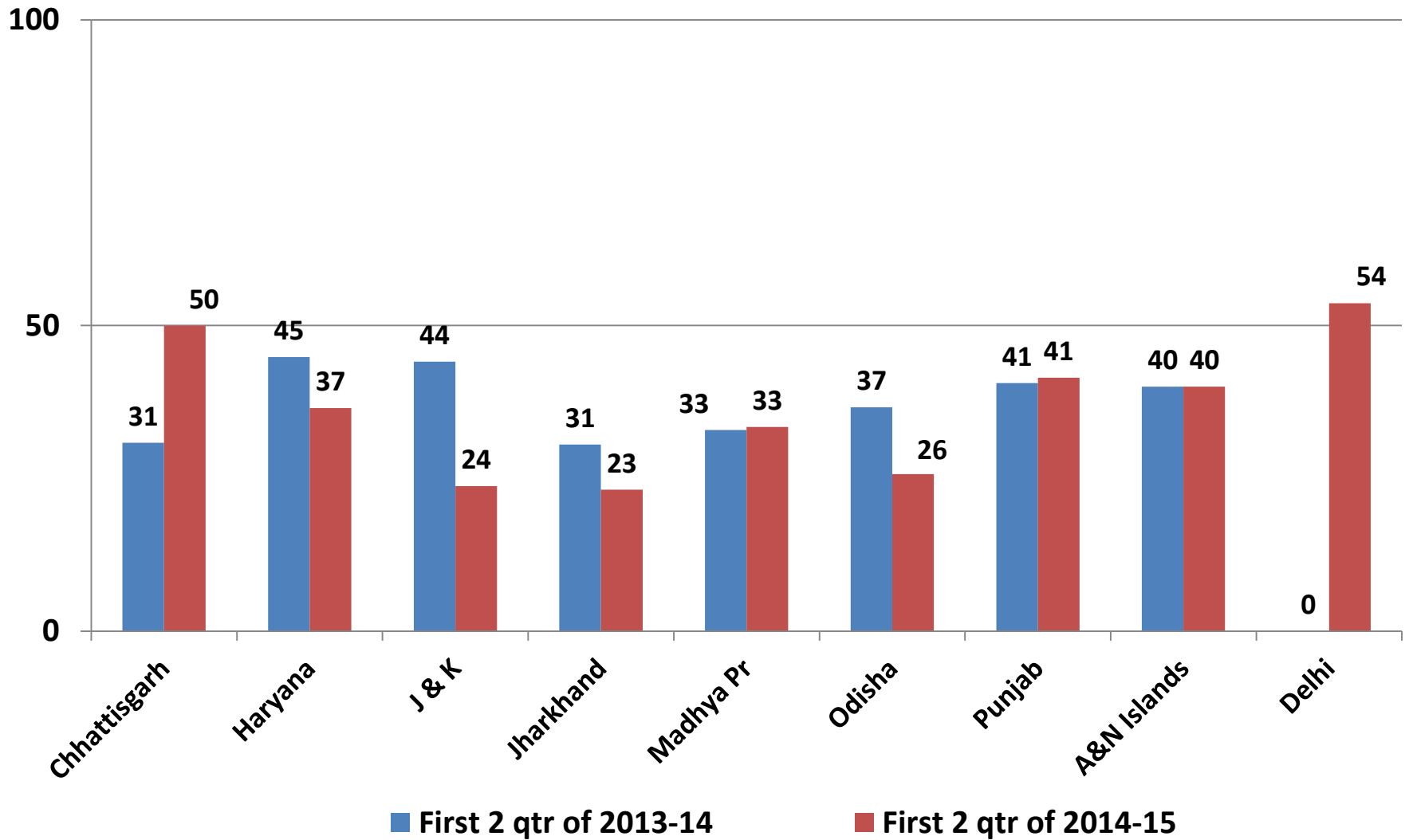
Cooking Cost Utilisation



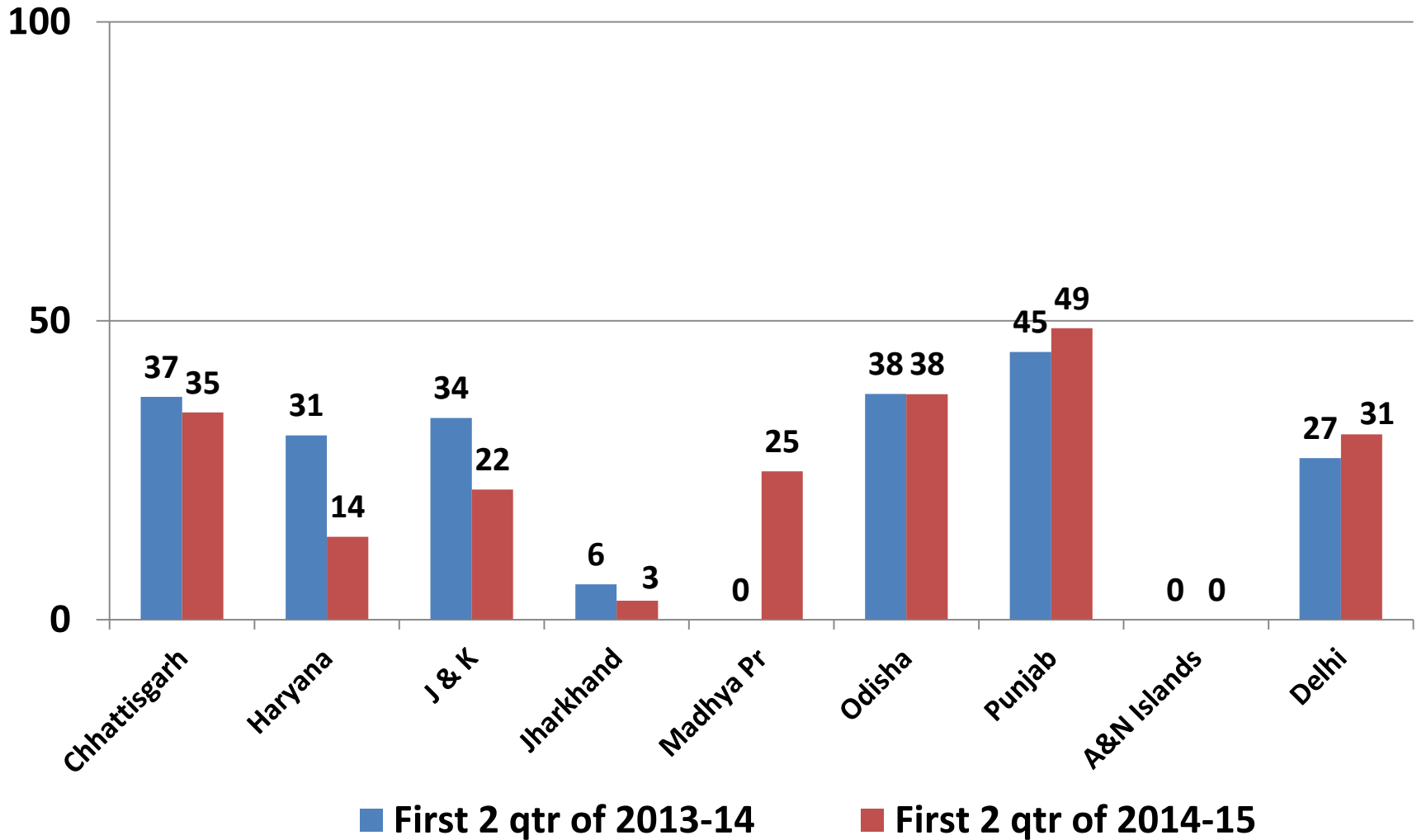
