

Sir/Madam,

The National Programme of Mid Day Meal in Schools, popularly referred as the Mid Day Meal Scheme (MDMS), is a flagship programme of the Government of India. This vast Mid Day Meal Scheme covers about 10.80 crore children in 11.58 lakh schools across the country. The current year's budget for MDMS is Rs. 13,215 crore.

The guidelines of the Mid Day Meal Scheme envisage monitoring structures at various levels for supervision and monitoring. In order to further strengthen the monitoring mechanism, Ministry of Human Resource Development (MHRD) constituted a District Level Committee under the Chairmanship of the senior most MP in the district. A copy of the OM dated 28<sup>th</sup> September, 2013 constituting the District Level Committee is enclosed. The States / UT shave also been informed about the constitution of the District Level Committee.

You will kindly notice from the above OM that the senior most Member of Lok Sabha is the Chairman of the District Level Committee which is to meet at least once in a quarter. Other members of the Parliament are nominated as Co-Chairperson of the District Level Committee. The nominations of the Chairperson / Co-Chairperson are governed by Ministry of Rural Development order no. Q-13018/06/2009-AI-V&MC(RD) dated 26<sup>th</sup> August, 2009, as amended from time to time. The District Magistrate / Deputy Commissioner of the district is responsible for ensuring that the meetings take place within 15 days of the end of the quarter.

I request you to kindly take up the matter with the District Administration in your constituency for holding the meeting of the District Level Committee. I am sure that your rich experience, dedication and vision would guide in further improving the implementation of the Scheme at the grass-root level by focusing on the critical issues.

In addition, your valuable guidance for further strengthening the monitoring mechanism at grassroots levels through the School Management Committees, which comprise 75% parents of which 50% are women, and which is representative of the social composition of the area, would be very welcome.

I would also like to request you to consider funding from your MPLADS funds, for construction of dining spaces in school compounds so that children can take the Mid Day Meal in these dining spaces.

I shall be grateful for your valuable time and contribution in the above efforts.

## OFFICE MEMORANDUM

Subject:

Constitution of District Level Committee for Sarva Shiksha Abhiyan (SSA) programme, Mid Day Meal (MDM) scheme and Rashtriya Madhyamik Shiksha Abhiyan (RMSA) and Sakshar Bharat programme – monitoring of these programmes/schemes – regarding.

In partial modification of this Ministry's Office Memorandum of even number dated 25<sup>th</sup> April, 2013 on the subject "Sarva Shiksha Abhiyan (SSA) — Revision in Framework for implementation of SSA", the undersigned is directed to state that it has been decided to constitute a District Level Committee for monitoring of Sarva Shiksha Abhiyan (SSA) programme, Mid Day Meal (MDM) scheme and Rashtriya Madhyamik Shiksha Abhiyan (RMSA) and Sakshar Bharat programme. The composition of the Committee is as under:-

- All Members of Parliament, Members of the State Legislature and members of the Zila Parsihad (wherever duly constituted), elected from that district/and or urban bodies (duly constituted) as applicable.
- The District Magistrate/Collector/ Deputy Commissioner/Chief Executive Officer of the Zila Parishad/Urban local body, will be the Member-Secy.
- District Education Officers in-charge of SSA, MDM, RMSA and Sakshar Bharat.
- District officers in-charge of Drinking Water Mission/ Total Sanitation Programme/ ICDS programme/ Panchayati Raj/ Labour/ Handicapped Welfare/ Social Welfare/ Minority Welfare etc.
- Two NGO's working on elementary education in the area, to be nominated by the District Magistrate/Collector/Dy. Commissioner/CEO Zila Parishad.
- 2. The senior most Member of Lok Sabha would be the Chairperson of the District Level Committee. Other Members of Parliament would be nominated as Co-Chairperson of the District Level Committee.

The nomination of Chairperson / Co-Chairpersons would be governed by Ministry of Rural Development Order No. Q-13018/06/2009-Al-V&MC(RD) dated 26<sup>th</sup> August, 2009, as amended from time to time.

- 3. Terms of Reference of the District Level Committee:
  - The Committee will be apprised of the progress of the SSA, RMSA, MDM and Sakshar Bharat implementation in the district, both in terms of key targets and achievements thereof, and also on outcome indicators, inter-alia, enrolment, dropout, learning achievement levels of students, literacy etc.

- Suggestions of the members may be taken into consideration, within the
  parameters of the scheme guidelines and framework of implementation and the
  approved annual work plans & budget of the district, for improving SSA, RMSA,
  MDM and Sakshar Bharat implementation at the local level.
- The Committee may also examine the synergy and convergence of other related Government Departments in improving school infrastructure and other support services for benefit of children in the 6-14 and 14-16 years age group and for Sakshar Bharat programme.
- 4. The Committee will meet at least once a quarter. The Member Secretary of the District Level Committee will be personally responsible for ensuring that the meetings take place within 15 days of the end of the quarter. In case, the Chairperson is unable to preside over the meeting for unavoidable reasons, the Member Secretary will ensure that the meeting is chaired by a Co-Chairperson.
- 5. Minutes of the Committee will be put up on an appropriate district level website as determined by the District Magistrate/Deputy Commissioner/CEO, Zila Parishad, so that it is in the public domain.
