#### REGULARITY IN SERVING MEAL:

Whether the school is serving hot cooked meal daily? If there was interruption, what was the extent and reasons for the same?

In most of the schools Mid Day Meal is not served daily and there is an interruption of 15-20 days because of non availability of food grains. Only some schools have managed to provide MDM by either getting food grains on loan or by having buffer.

#### REGULARITY IN DELIVERING FOOD GRAINS TO SCHOOL LEVEL:

(i) Is school/implementing agency receiving food grain regularly? If there is delay in

delivering food grains, what is the extent of delay and reasons for the same?

MI observed that in most of the schools visited the school implementing agencies are not receiving food grains regularly. Grains are received with interruption because of non availability of food grains at Govt. ration depots. Extent of Delay varies from 10 to 15 days.

Is buffer stock of one-month's requirement maintained?

Buffer stock of one-month's requirement is not maintained in any of the visited schools.

(ii) Is the quantity of food grain supplied as per the marked/indicated weight?

Food grains supplied are as per marked weight.

(iii) Is the food grain delivered at the school?

As per the information received from MDM in-charge food grains are not delivered at school.

(iv) Is the quality of food grain good?

Quality of food grains supplied to the schools was found good.

#### REGULARITY IN DELIVERING COOKING COST TO SCHOOL LEVEL:

(i) Is school/implementing agency receiving cooking cost in advance regularly? If there is delay in delivering cooking cost, what is the extent of delay and reasons for it?

Cooking cost is not received regularly by the school/implementing agency. The extent of delay varies from 3 to 4 months as MDM funds are received by the schools when released from CEO's Office.

(ii) In case of delay, how school/implementing agency manages to ensure that there is no disruption in the feeding programme?

In 25% schools MDM in-charge with the help of school management committee ensures feeding of MDM to the students. Amount spent is either managed out of school grants or by the school staff. In Zone Hariganiwan and Tulmulla 50% of visited schools have not served MDM for 60 to 100 days.

(iii) Is cooking cost paid by Cash or through banking channel?

The cooking cost is paid through banking channel

All the children take meals together and at the same time. No discrimination was observed by MI personnel in serving or seating arrangements.

MDM is served either in the lawn or verandah of the school. In 40% of schools

		students take meals at a place of their liking in the lawn or at verandah. In 60% of visited schools students take meals in an orderly manner.

No such roaster was maintained by community members for supervision of the MDM.

#### INSPECTION & SUPERVISION

i) Has the mid day meal programme been inspected by any state / district / block level officers/officials?

Mid Day Meal Programme is being inspected by representatives from Chief Education Office and Zonal Education Office occasionally.

ii) The frequency of such inspections?

The inspection by these representatives is made once in two months.

#### IMPACT

Has the mid day meal improved the enrollment, attendance of children in school, any improvement in general well being, nutritional status of the children (to be verified from school record, discussion with students, teachers and parents. Is there any other incidental benefit to the children and school due to serving of mid-day-meal by VEC, PRI members?

MDM has definitely improved the enrollment, attendance and general wellbeing of the children. In fact in most of the schools MDM is attraction for students to attend schools.

#### B. Any other issues relevant to MDM implementation

- Mid-Day-Meal Programme is hardly supervised by any State, District or Block Level
  officers. Supervision of Village Education Committees is not regular in the District. Thus
  the loopholes/shortcomings in the implementation of MDM never come to fore for the
  timely remedial measures.
- In-charge Teachers MDM have not received training on nutritional aspects of meals served to the students, besides they are ignorant about maintenance of health card for each child and administering de-worming medicines and micro nutrients.
- Roaster was not displayed in almost all the schools. Menu is decided by in-charge MDM irrespective of the fact whether balanced diet is served or not, as they have no idea regarding balanced diet.
- MDM funds are not released in time due to which cooks have to wait for months together for their honorarium. Besides there is delay in serving of MDM in most of the schools.

• MDM in charge is wholly responsible for the implementation of MDM, due to which he is over burdened with this assignment and can't do justice with his teaching in the class rooms.

	Yes, schools are receiving food grains regularly but delay in delivering food grains has also been reported. Usually the delay is due to no availability of grains at food depots. This delay lasts for 2-3 months, but school authorities are managing the MDM.
	(ii) Is buffer stock of one-month's requirement maintained?
	Yes, buffer stock of one month's requirement is maintained.
	(iii) Is the food grain delivered at the school?
	No, food grains are being lifted from the food deport by the MDM in charge of the respective schools.
	(iv) Is the quality of food grains good?
	The food grains are of good quality as reported by VECs and teachers and M.I also found the same.
	(iv) Is school / implementing agency receiving cooking cost in advance regularly? If there is delay in delivering cooking cost, what is the extent of delay and reasons for it?
	As reported by VECs and in charge MDM of respective schools, the schools are not receiving cooking cost in advance there is always delay of 3-4 months. This delay is due to late release of grants from District to zones and zones to schools.
	(v) In case of delay, how school/implementing agency manages to ensure that there is no disruption in the feeding programme?
	The school management committee manages by mutual contribution and ensure regular feeding programme in the schools. But as reported there has been interruption in serving MDM.

	As reported by VECs and cooks the cooking cost is paid by cash against a proper receipt. However directions have been passed by SSA authorities for releasing of cooking cost through banks.

MDM programmer has improved enrollment in the schools & also providing nutritional requirements to the children. It has also inculcated ethics & values of brotherhood and & discipline among the children. There is dire need of constructing kitchen sheds in the schools and also ensure un interrupted release of cooking cost, honorarium to cooks and supply of grains.

#### B. Any other issues relevant to MDM implementation

There is a very good response by the community, parents, teachers & students with regard to MDM programme it has not only increased the enrolment but also developed the spirit of community involvement in the educational process .But a lot is yet to be done on account of proper implementation of the programme without any delay & continuous supervision is also to be ensured. The authorities must ensure the objective for which the programme is being implemented. There should be one person wholly & solely responsible for MDM programme in each school & not a teacher. Because a teacher if involved in MDM programme like lifting of grains, account of cooking charges etc is deviating him from his teaching work, as has been reported by all the teachers in the schools. There should be also a separate and well-furnished place for consumption of MDM. The HRD ministry should impress upon the state implementing agencies to take the MDM programme as an important and serious responsibility and also evolve a strong monitoring mechanism in the state. The state should also ensure accountability at all the levels especially at SPD and District level to make the MDM more effective, successful and result oriented.

90% of the visited schools are receiving food grains regularly and 10% of the visited schools did not receive food grains even after a delay of more than one month. As per the reports many schools did not receive food grains due to non availability of the funds.

Buffer stock is maintained in almost all the visited schools.

The quantity of food grain supplied to the schools is as per the marked/indicated weight.

The food grain is not delivered at the schools, the teachers in charge MDM are lifting it from the concerned food stores.

As per the observation the quality of food grains was found good in almost all the visited schools.

The school implementing agencies are not receiving cooking cost in advance at all. The schools are provided cooking cost after a delay of more than three months.

In case of delay the school staff manages to ensure the feeding programme by self contribution.

The payment of cooking cost is made through banking channels.

The remuneration paid to cooks cum helpers is Rs 1000 per month per cook and the payment is made through banking channels.

The remuneration is not paid regularly to the cooks. They are receiving payment after a delay of more than five months.

As observed by MI 10% of the visited schools have kitchen shed but not in use due to minor repairs or unsafe structures.

As reported by the concerned DPO there is no Kitchen shed sanctioned for the year 2011-12.

As observed by MI 25% of the schools do not have kitchen sheds sanctioned.

25% of visited schools were found without kitchen sheds which causes problems for storage of ingredients and cooking process.

The MI observed that the schools without kitchen sheds are storing and cooking MDM in the classrooms, offices, and in the homes of the cooks.

• Weather potable water is available for cooking and drinking purpose?

All the schools visited have portable water available for cooking and drinking purpose.

• Whether utensils are available for cooking food? If, available is it adequate?

The MI observed that all the schools have adequate utensils available for cooking food except few schools were rice bins and bun tons were not available for cooking.

• What is the kind of fuel used? (Gas based/firewood etc.)

75% schools are using LPG and 25% fire wood for cooking MDM.

#### • SAFETY & HYGIENE:

x. General Impression of the environment, safety and hygiene:

All the schools visited by MI have satisfactory environment, safety and hygienic conditions except few schools were utensils were unhygienic.

**xi.** Are children encouraged to wash hands before and after eating

As observed by MI all the children are encouraged to wash hands before and after eating.

xii. Do the children take meals in an orderly manner?

All the children are taking meals in an orderly manner.

xiii. Conservation of water?

The MI observed that most of the school children are not maintaining the values of conservation of water.

xiv. Is the cooking process and storage of fuel safe, not posing any fire hazard?

All the schools visited by MI have the cooking process and storage of fuel safe and is not posing any threat of fire hazard.

#### • COMMUNITY PARTICIPATION AND AWARENESS\*:

Only VECs and surpanch in some of the schools are supervising and monitoring MDM programme in the schools but participation of parents is very less.

vi) Is any roster being maintained by the community members for supervision of the MDM?

No roster is maintained by the community members for supervision of the MDM in any of the schools.

#### INSPECTION & SUPERVISION

v) Has the mid day meal programme been inspected by any state / district / block level officers/officials?

As reported by the VECs the mid day meal programme is inspected by the district / block level officers/officials only once in last three months.

vi) The frequency of such inspections?

The frequency of such inspections of DPO officials is taking place once or twice a year.

#### IMPACT

Has the mid day meal improved the enrollment, attendance of children in school, any improvement in general well being, nutritional status of the children (to be verified from school record, discussion with students, teachers and parents. Is there any other incidental benefit to the children and school due to serving of mid-day-meal by VEC, PRI members?

As per the discussions held with the students teachers and parents of the school children the MDM scheme has considerably improved the enrollment, attendance nutritional status and general well being of the school going children particularly the children of the deprived sections of the societies like BPL families Gujars, pahri and the Hanji communities.

#### B. Any other issues relevant to MDM implementation.

The MI observed that the schools without Kitchen shed do not properly maintain the kitchen items like utensils food grains, and other items due to lack of the place. There is a need of orientation of the implementing agencies on the operation of MDM scheme as per norm.

Most of the visited schools have 100 and above enrollment but only one cook for cooking MDM due to which the MDM is served in time to the children. The VEC are almost nonfunctional in most of the schools due to which they are not realizing the role and responsibility in the scheme of SSA and MDM and therefore MDM implementation is not supervised or checked by the VEC regularly. In almost all the visited schools there is lack of coordination among the VECs, Parents and the School teachers and hence no regular meetings, discussions and resolutions are taking place for smooth operation of MDM in the schools. There is lack of awareness among the VECs, community and teachers about their role in implementation of SSA and MDM in the schools and therefore MDM is not regularly monitored, supervised or inspected by the VECs and the parents.

The schools do not consult VEC or Parents for preparation of weakly roaster for MDM of the schools. The statistical data of the children availing MDM, cash books and Registers are not updated and maintained properly. The monitoring mechanism of MDM is very poor in the district and the district, block and the village implementing agencies are not regularly supervising or monitoring the MDM operation.
