Subject: Proposals for release of funds towards provision of MDM / Food Security Allowance (FSA) during summer vacations as a one time special measure due to COVID-19, under Mid Day Meal Scheme

Madam / Sir,

As you are aware, Hon'ble Minister, Human Resource Development, Government of India, announced during a video conference with the State Education Ministers on 28th April, 2020 that MDM or Food Security Allowance comprising of food grains and cooking cost (or its equivalent pulses, oil etc.) will be provided to the school children even during summer vacations so as to enable them to meet their nutritional requirement and to safeguard their immunity which is very vital during COVID 19 pandemic.

- 2. Accordingly, MHRD advised all States and UTs vide letter dated 29th April, 2020 for provision of mid-day meal or Food Security Allowance to the eligible children under Mid-Day Meal Scheme during summer vacations of 2020-21. The proposals submitted by States and UTs as a part of AWP&B have also been considered by the PAB.
- 3. As the summer vacations are already over or about to be over across the country, the States and UTs are requested to submit the following:
 - i) A detailed note covering the aspects of methodology adopted for distribution of Food Security Allowance, and the mechanism followed for management and monitoring.
 - ii) A statement duly countersigned by Secretary (Education / Nodal department for MDMS) on actual expenditure incurred on Foodgrains, Cost of Foodgrains, Cooking Cost and Transportation Assistance for providing Food Security Allowance during summer vacations (*Annexure*).
- 4. You are therefore requested to provide the above information positively by 15th July, 2020. Scanned copies of these may also be sent by email to respective Director / Deputy Secretary and Chief Consultant / Senior Consultant / Consultant.
