Dear Secretary,

Kindly refer to my d.o. letter of even no. dated 12th December, 2017 regarding submission of Annual Work Plan & Budget 2018-19 under Mid-day Meal Scheme for consideration by Programme Approval Board – Mid Day Meal (PAB-MDM).

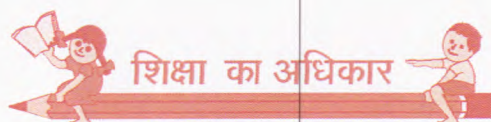
2. As you are aware that the meetings of the PAB-MDM used to commence from the month of February. The States and UTs were required to submit the information in the prescribed formats for the implementation of the scheme for 3 quarters only of the financial year. However, these meetings are scheduled to commence from 9th May, 2018. Therefore, the States and UTs are now required to submit information for the whole financial year in the prescribed formats which have been accordingly revised. These formats can be downloaded from the MDM website mdm.nic.in.

3. A new format relating to availability of safe drinking water and water filtration facilities in the schools has also been included in the formats at **Table No. AT-10 F**. The States and UTs are requested to submit information in this regard in both write up as well as table formats.

4. It is once again reiterated that before submitting the AWP&B 2018-19, the States and UTs should ensure that the AWP&B duly signed by the State/UT's Principal Secretary/Secretary of Education or the Nodal Department after approval by the State's Steering-cum-Monitoring Committee (SSMC).

5. A confirmation may also be made in respect of following:

- i. The State is e-transferring the funds to all schools.
- ii. 100% payment of cost of food grains has been made to Food Corporation of India.
- iii. All bills of FCI for the previous years have been paid.
- iv. All the cook-cum-helpers have been paid honorarium on monthly basis up to the previous month of PAB meeting through e-transfer in to their bank accounts.

- v. Annual and Monthly data entry for 2017-18 has been completed.
- vi. Emergency Medical Plan is in place in all schools.
- vii. Action Taken Note on the commitments given by the State during PAB meetings of 2017-18 has been furnished to MHRD.
- viii. Separate MME Plan has been submitted by the State.


6. The appraisal schedule of AWP&B is enclosed at Annexure-I for your information, further necessary action. You are requested to ensure that your AWP&B 2018-19 is submitted on or before the scheduled date of its submission. The State Plan along with all District Plans should also be uploaded on the MDM-MIS portal as was done for the year 2017-18.

7. You may advise the concerned officers to go through the formats of the State/District Plans for preparing a comprehensive Annual Work Plan & Budget 2017-18.
