- ii) Less utilization of food grains (60%).
- iii) Variation of utilization of cooking cost (88%) and food grains (60%).
- iv) 13,634 cook-cum-helpers did not engage.
- v) 62% schools are using fire wood as a mode of cooking.
- vi) Gazette notification of MDM Rules, 2015 has not discriminated to the District/Block/Schools.
- vii) Kalimpong district data not provided in the AWP&B 2018-19.

#### **D.** Best practices

- i) Rs.500 additional to Cook-cum-Helper as honorarium from State's fund.
- ii) Eggs are served once a week to all the children.
- 50gm chicken per child once a week in 11 districts (Bankura, Hoogly, Howrah, Malda, Cooch Behar, Murshidabad, Nadia, Purba Medinipur, South 24 Parganas and North 24 Parganas).
- iv) Paneer 25gms are served once in a quarter in Malda district and Cheese 50gms are served once in a week in Uttar Dinajpur district.
- v) 6966 (8%) schools have kitchen gardens. In Purulia district 90% schools have kitchen garden.
- vi) Total 2973 dining hall constructed (1403 dining halls constructed through state funds and 1570 dining hall constructed from MPLAD funds in different districts.
- vii) 79.95 lakh units of eating utensils purchased from State funds.

#### Part-A: General Information

The MDMS was launched on 15th August, 1995 with a view to enhancing enrolment, retention, attendance, reducing dropouts and simultaneously improving nutritional levels among primary children in class I to V. Initially the students were served uncooked food and that did not help the scheme achieving the objective. Consequently, Cooked Mid-day Meal Programme was introduced in West Bengal in January, 2003 in 1100 schools of six districts to start with. Thereafter, all the districts have been covered. The programme was further extended to the upper primary stage of schools education (class VI to VIII) in Govt. Govt. aided schools, and EGS/AIE centers in 2007-08. Thereafter, coverage of schools has increased gradually and during 2017-18 the programme has covered cent percent of Govt., Govt. aided schools, and EGS/AIE centers with 6497969 students from class I-V of 67536 Primary levels and 4230973 students of class VI-VIII of 16154 Upper Primary level.

Based on the information provided by the State administration in its AWP&B 2017-18, the performances during 2017-18 (01.04.17 to 31.03.2018) have reviewed by the appraisal team. The major issues in implementation during 2017-18 are summarized as under: -

#### 2.0. Coverage of Institutions

#### 2.1 <u>Coverage of Children</u>

#### 2.1.1 <u>Coverage against enrolment</u>:

a) Primary - Coverage in terms of No. of children. Difference between Enrolment vs. Average No. of Children Availed MDM (Achievement) (Ref*er Table 2.3 of the Analysis Sheet).*

Average number of children availed MDM during 01.04.17 to 31.03.18 = 6497969 (89%).

The low coverage of districts viz. W/Bardhaman (84%), Malda (85%), D/Dinajpur (86%), Kolkata (86%), E/Medinipur (86%), Jalpaiguri (87%), Murshidabad (88%), Hooghly (88%) and Nadia (88%) are below the State average.

Low coverage of children in Upper Primary are observed in districts are Kolkata (84%), W/Bardhaman (86%), D/Dinajpur (87%), E/Medinipur (88%), Jalpaiguri (88%), Hooghly (88%), Malda (88%), Murshidabad (88%) and Nadia (89%) It is advised to State to find out the reasons for such low coverage against the enrolment and develop mechanism for covering more children under the scheme.

### 2.2.1 Level of Opening Balance as on 01.04.17: (Refer Table 3.2 of the Analysis Sheet).

The State had informed that 22857.47 MTs almost (7%) opening balance of food grain available with State as on 01.04.17.

### 2.2.2 Level of unspent balance as on 31.03.18: (Refer Table 3.3 of the Analysis Sheet).

The State level closing balance as on 31.03.18 is 23717.97MTs (7%) against the total allocation of **330767.22** MTs.

### 2.2.3 Availability of Food grains: (01.04.17 to 31.03.18) : (Refer Table 3.5 of the Analysis sheet)

At the end of the year i.e. 31.03.2018, availability food grains was 245925.73 MTs i.e. 74% of the food grains allocation.

#### 2.2.4 Utilization of food grains: (Refer Table 3.7 of the Analysis sheet)

An analysis of the utilization of food grains during 2017-18 shows that State has utilized 191685.74 (58) % of the allocated food grains. Districts like GTA (39%), Siliguri (42%), N/24 Pgs. (48%), Kolkata (48%), D/Dinajpur (49%), Nadia (51%), Malda (54%), Jalpaiguri (54%) and Cooch Behar (55%) have utilized less than the state average. State is advised to find out the reasons for low utilization of food grain in these districts.

#### 2.2.5 Payment of cost of food grains to FCI: (Refer Table 3.9 of the Analysis sheet)

Allocation of cost of food grains for the year 2017-18 was Rs. 9237.28 lakh. The FCI submitted bills for Rs.6006.31 lakh during 1.4.2017 to 31.03.2018 towards cost of food grains. The State has made payment for an amount of Rs. 6006.31 Lakh (100%) to the FCI. However, as per the FCI statement an amount of Rs. 718.87 lakh is pending as on 31-03-2018. State is advised to reconcile the FCI bills and make payment of cost of food grains to FCI.

#### 2.3 COOKING COST (PRIMARY + UPPER PRIMARY)

### 2.3.1 Level of Opening balance as on 01.04.17: (Refer Table 4.1.1 of the Analysis Sheet)

The State had reported Rs. 19886.17 lakh (15%) as opening balance at the beginning of the financial year 2017-18. Huge opening balance is observed in the districts viz. Siliguri (44%), GTA (35%), E/Medinipur (32%), Cooch Behar (29%), Alipurduar (26%), Birbhum (24%), Murshidabad (21%), D/Dinajpur (19%), Bankura (19%), Hooghly (18%), Purulia (17%) and W/Medinipur (17%). State is advised to find out the reason of huge opening balance of cooking cost in the above cited districts.

### 2.3.2. Level of closing balance as on 31.03.17: (Refer Table 4.1.2 of the Analysis Sheet)

The State had closing balance of Rs. **22626.62**lakh (17% of allocation) towards cooking cost as on 31.03.2018. Huge unspent balance of cooking cost are observed in the districts like Jalpaiguri (25%) GTA (25%), N/24 Pgs. (25%), D/Dinajpur (25%), Alipurduar (23%), S/24 Pgs. (22%), Cooch Behar (21%), Malda (20%), Jhargram\* (19%), Birbhum (18%), Kolkata (18%) and U/Dinajpur (18%).

#### 2.3.3. <u>Utilization of Cooking cost: (Refer Table 4.5 of the Analysis Sheet)</u>

In the end of the year i.e. 31-03-2018, State level utilization of cooking cost is Rs.119809.47(88%) against allocation. Low utilization of cooking cost have observed in the districts viz. GTA (77%), Jhargram\* (81%), Kolkata (82%), Alipurduar (83%), Malda (83%), Burdwan (84%), W/Bardhaman\* (84%), Purulia (84%), Birbhum (84%), Cooch Behar (85%), D/Dinajpur (85%), E/Medinipur (86%), U/Dinajpur (86%) and Siliguri (87%). These districts' cooking cost utilization is below the State average.

### 2.4. <u>Reconciliation of utilization and performance during 2017-18 (01.04.17 to 31.03.18)</u>

### 2.4.1. <u>Mismatch in utilization of Food grains vis-à-vis cooking cost: (Refer Table – 5.1 of Analysis Sheet)</u>

Ideally the percentage utilization of cooking cost and food grains should tally with each other. The data furnished in the AWP&B reveals that there is huge mismatch of 30% at State level in utilization of cooking cost (88%) and food grains (60%). Huge mismatched observed between utilization of cooking cost and food grain in the districts viz. Siliguri (-45%), N/24 Pgs. (-43%), GTA (-39%), Jalpaiguri (-36%), Nadia (-36%), D/Dinajpur (-36%) and Kolkata (-34%). State Govt. advices to conduct district wise study and find out the reason of huge mismatched of food grains vis-à-vis cooking cost.

### 2.5. <u>Cook-Cum-Helper (PRIMARY + UPPER PRIMARY)</u>: <u>(Refer Table – 6.1 of Analysis Sheet)</u>.

MDM-PAB has approved 248799 cook-cum-helpers to be engaged during 2017-18 at the school level. The State has engaged 235165 cook-cum-helpers. State could not engage 13634 cook-cum-helpers during the year 201-18. The State made payment of Rs. 35465.03 lakh (95%) of the allocated funds for payment of honorarium to cook cum helpers.

#### 2.6. Utilization of MME (Refer Table – 7.2 of Analysis Sheet)

Against the allocation of Rs. **1966.50** lakh as Central Assistance towards MME funds, the State has utilized only 100%. As per MDMS guidelines 50% of the MME funds are earmarked for school level expenditures. As per the data provided in the annual work plan budget 2018-19 State allocated 50% MME expenditures in Schools expenses and 50% for management activities for the year 2017-18. However, State utilized 140% in management activities whereas only 51% MME expenditure made at the school level.

#### 2.7. <u>Utilization of Transportation Assistance</u> (Refer Table – 8.2 of Analysis Sheet)

An amount of Rs.2480.75 lakh was allocated for transportation assistance of the food grains to schools as Central Assistance. Rs. 776.48 lakh was opening balance as on 01-04-2017. State has utilized 100% on this head.

#### 2.8. Construction of Kitchen-cum-stores (Reference Table -9.1.3 of Analysis Sheet)

Central assistance of Rs. **85818.44** Lakh has been released for construction of 81314 Kitchen-cum-Stores. Out of 39001 kitchen-cum-stores sanctioned till 2017-18. State has constructed 100% Kitchen-cum-stores. It has been noticed that an amount of 268 kitchen-cum-stores @Rs.2.00 lakh per units has been sanctioned by the PAB 2017-18. However, State Government of West Bengal has revised their unit cost to Rs. 2.87 lakh per unit by the later dated 15.02.2018. The approval of Secretary (SE&L) as Chairman of PAB may be solicited for revised proposal i.e. total expenditure of Rs.769.16 lakh & Central Share of Rs. 461.50 lakh for construction of 268 numbers of kitchen-cum-stores for the State Govt. of West Bengal as approved in PAB 2017-18. Thereafter, the file was referred to IFD for their concurrence of the above proposal. The details of Kitchen-cum-Stores in the GFR-12C format have been submitted on 08-05-2018 by the State Govt. of West Bengal. File is under submission.

#### 2.9. Procurement of Kitchen devices (Reference Table -9.2.2 of Analysis sheet)

An amount of Rs. 1856.59 lakh has been released as Central Assistance towards procurement of 37132 units of kitchen devices during 2006-07 to 2017-18. The State has reported that 37124 the units of kitchen devices have been procured. 8 Kitchen devices unable to procure by Chartra District. 3989 units of kitchen devices were approved by PAB 2015-16 and the file is under process.

### 2.10. <u>Procurement of replacement of Kitchen Devices (Ref. Table 9.2.5 of Analysis Sheet)</u>

90855 units of kitchen devices have sanctioned for replacement during 2006-07 to 2017-18 and allocation for an amount of Rs. 4542.75 Lakh. State procured 100% units of kitchen devices up to 31-03-2018. An amount of Rs. 2387.15 for total replacements of 47743 units of KDs was sanctioned by PAB during 2012-13 to 2017-18. State procured all the sanctioned units. PAB-2016-17 approved an amount of Rs. 2499.05 lakh for 49981 units of KD for replacement.

It is to be noted Rs. 390.50 lakh has been released to Govt. of West Bengal for 7810 units of Kitchen Devices out of 49981 units of kitchen devices sanctioned during 2016-17. An amount of Rs. 2108.54 lakh for remaining 42171 units of Kitchen Devices could not be released due to paucity of fund during 2016-17. However, the release of pending amount of Rs. 2108.54 lakh for 42171 units of Kitchen Devices has been put up on file to IFD and same is under submission.

**2.11. Utilization of MME Funds:** Against the allocation of Rs. 975.53 lakh as Central Assistance towards MME funds, the State has utilized 100% fund. However, MME fund utilized on Schools level expenses is only Rs. 501.16 lakh (26%), where as an amount of Rs. 1449.91 lakh expenditure made on management, supervision, training and internal & external Monitoring & evaluation heads by the State. As per MDMS guidelines 50% of the MME funds are earmarked for school level

expenditures, out of the total utilized funds, 74% have been utilized at the school level.

#### 3. Data Entry Status on the MIS Web Portal

In order to smooth function of MDMS, Ministry of HRD, MDM Division has developed web-based online monitoring system i.e. Web based MIS in collaboration with NIC. In this web portal State/District/Block users must make Annual and Monthly data entry into the web portal through online. The State should monitor data entry activities to be made timely manner by District/Block users into the portal. The Annual and monthly data entry status as 31-03-2018 of the district wise are given below: -

#### 3.1. <u>Annual Data Entry Status:</u>

State has completed 100% schools' annual data entry for the year 2017-18 into the MIS Web Portal. The district wise annual monthly data entry status is given below: -

It is observed that two districts Cooch Bihar and Paschim Bardhaman have did not complete 100%. It is advised to State that these districts should be monitor for data entry few schools left pending for annual data entry into the MIS web portal. State

also requested to kindly send the school master details to MHRD for bifurcation of three newly constructed Districts to update into the MIS Web server.

3.2. Monthly Data Entry Status:- It is appreciated that monthly data entry have been 10%% completed by district of the West Bengal except Paschim Bardhaman (99%).



Graphical representation of the data comparison with MIS and AWP&B- 2017-18 is given below:



In all the districts of West Bengal observed that more schools are reporting daily through AMS except Darjeeling. State are also analysis the data received from the AMS and also compare AMS data with the quarterly progress report data before submit to the MHRD.

#### 4. Release of funds:

The Central Govt. has released Ad-hoc Recurring Central Assistance of Rs. 278.04 crore to Govt. of West Bengal on 04-05-2017. The funds were released to districts by the directorate on 27.06.2017. The Central Govt. has released balance of the first installment of Rs. 252.05 crore to the State on 07.07.2017. The funds were released to districts by the directorate on 15.09.2017. An amount of Rs. 441.38 crore released on 01-01-2018 as full and final Installment of recurring Central Assistance to the Govt. of West Bengal. This fund was released to districts on **22.02.2018**.

#### 5. Management Structure

The School Education Department, Govt. of West Bengal is the apex body for implementation of this scheme in the state. The State Level office of CMDMP under its administrative control is managed by following officials:-

- i). Project Director (In service)
- ii). Administrative Officer On contract
- iii). Dy. Director(Civil) On contract
- iv). Dy. Director(Food) On contract
- v). Officer on Special Duties On contract
- vi). Accounts Officer (In-service Officer)
- vii). MIS Coordinator (In-service)
- viii). Accountant (one) On contract
- ix). Head Assistant (one) On contract
- x). UDC (2 no's) On contract
- xi). Data entry Operator (3 no's) On contract
- xii). Gr.-D (one) On contract

In the districts, the District Magistrate is the Nodal Officer. With the help of Sub-Divisional Officers and Block Development Officers, he administers the MDM programme.

#### 6. Capacity Building

A training programme of the Cook-cum-helpers organized to acquaint with the latest scientific methods of cooking MDM food with a view to making MDM tasty and cost effective. 10 cook cum helpers nominated from each district to obtain training as Maters Trainers.

#### 7. Tasting of Meal:

Every school maintains register for tasting of meals. Before serving of cooked food to children, teacher, cook cum helper and parents present at that time in school tasted the cooked food and record their remarks in register.

#### 7. Grievance Redressal Mechanism

At state, district and block level – A grievance complaint register was maintained about grievances and their redressal as well as communication with concern authorities, schools at various level.

#### 9. Contingency Plan to avoid any untoward incident

Govt. of West Bengal has issues orders and instruction provided to all the schools about necessary safety measures for maintenance of health and hygienic aspects of MDM. Use of AGMARK and sealed cooking oil and condiments, use of packaged iodized salt, tasting of cooked food by one teacher, one cook and one guardian before serving the MDM to the students. Ensure installation of fire extinguisher in every school etc. Besides, every school has being displaying emergency contact numbers of nearby health centre, fire service, BDO, SI of school and local police station. Besides, all the schools have been asked to keep first aid box to tackle emergency situation. A guideline vide No. 39(22)-ES(CMDMP)/GENL-43/2013 dt: 20.01.2014 has been issued to all the schools for maintenance of safety as well as hygiene while serving hot cooked meals to the students.
