(AMS) i.e. only 25%.

4. Review of Performance during 2018-19

4.1 Performance on PGI indicators:

There are two indicators of Mid Day Meal Scheme in the Performance Grading Index (PGI) i.e. i) Score against the weightage of 10 for indicator No. 1.3.7 i.e. "% of elementary school's children taking MDM against target approved in PAB – in Govt. and aided schools" and ii) Score against the weightage of 10 for indicator No 1.3.8 i.e. "% of days Mid Day Meal served against total working days – Govt. and aided elementary schools."

4.2 Coverage of children:

The PAB-MDM has approved 92114 children at primary and 41336 children at upper primary level, out of which 87152 children at primary and 39021 children at upper primary have availed Mid Day Meal on an average basis during the year 2018-19.

Under 'Performance Grading Index' (PGI), the State of Mizoram obtained score of 10 against the weightage of 10 for indicator No. 1.3.7 i.e. "% of elementary school's children taking MDM against target approved in PAB – in Govt. and aided schools". The State was advised to take necessary steps to enhance the coverage of children at primary and upper primary level.

4.3 School Working Days:

The PAB-MDM has approved 202 working days at primary and 212 working days at upper primary level, out of which Mid Day Meal was served on all 202 and 212 working days for primary and upper primary levels respectively. Under 'Performance Grading Index' (PGI), the State obtained score of 10 against the weightage of 10 for indicator No. 1.3.8 i.e. "% of days Mid Day Meal served against total working days – Govt. and aided elementary schools".

4.4 Kitchen-cum-Stores:

Central Assistance of Rs. 3051.90 Lakh has been released from 2006-07 to 2018-19 for construction of 2532 Kitchen-cum-Stores. As on 31.3.2019, construction has been completed for 2506 Kitchen-cum-stores. The State of Mizoram has not started any construction work for 26 Kitchen-cum-Stores. The State was advised to complete the construction of remaining Kitchen-cum-stores by 30.09.2019.

The State of Mizoram has proposed repair for 1533 Kitchen-cum-stores with an outlay of Rs. 153.3 Lakh, which comprises of Rs. 137.97 lakh as Central share and Rs. 15.33 Lakh as State share. After detailed discussion, PAB-MDM approved repair of the same.

The Government of Mizoram informed that Kitchen-cum-store in two schools viz lana Middle School and Chapi Middle School in Siaha district have been completely destroyed due to cyclone and have requested for sanction of new Kitchen-cum-store for the same. The State has also submitted a proposal of 7 new Kitchen-cum-stores. Hence, 7+2 (destroyed Kitchen-cum-store in two schools mentioned above)=9 new Kitchen-cum-store according to plinth area norms with an outlay of Rs. 31.50 Lakh which comprises of Rs. 28.35 lakh as Central share and Rs. 3.15 Lakh as State share. After detailed discussion, PAB-MDM approved 9 Kitchen-cum-store with an outlay of Rs. 31.5 Lakh which comprises of Rs. 28.35 lakh as Central share and Rs. 3.15 Lakh as State share.

4.5 Kitchen Devices (new as well as replacement):

Central Assistance of Rs. 242.84 lakh has been released towards procurement as well as replacement of 4857 units of Kitchen devices. The State has reported that all the units of Kitchen devices have been procured.

608 units of Kitchen devices were also sanctioned during 2018-19 as replacement of kitchen devices. The Central Assistance of Rs. 71.10 lakh (as per PAB Approval 2018-19) could not be released as IFD has stated that the matter may be taken up in PAB 2019-20 due to revision of norms for Kitchen devices. The State has now submitted the revised proposal for 608 Kitchen Devices (as approved during PAB-MDM meeting in 2018-19) with an outlay of Rs. 79.00 Lakh, which comprises of Rs. 71.10 lakh as Central share and Rs. 7.90 lakh as State Share. After detailed discussion, PAB-MDM approved 608 Kitchen devices for replacement with an outlay of Rs. 79.00 lakh comprising of Rs. 71.10 lakh as Central share and Rs. 7.90 lakh as State Share.

The State of Mizoram has proposed Kitchen devices for 7 new schools with an outlay of Rs. 0.80 Lakh, which comprises of Rs. 0.72 lakh as Central share and Rs. 0.08 Lakh as State share. After detailed discussion, PAB-MDM approved 7 new Kitchen devices for the State of Mizoram for the FY 2019-20.

4.6 School Health Programme (Rashtritya Bal Swasthya Karyakram (RBSK), Weekly Iron & Folic Acid Supplementaiton, National De-worming Day etc.) and Nutrition in convergence with other Ministries:

It was observed that health check up has been carried out for 63,485 children, out of total enrolment of 1,36,951 children.

4.7 Training of Cook-cum-Helpers and other capacity building activities:

State has informed that out of total engaged 4894 cook-cum-helpers in 2524 schools, training has not been imparted to any cook-cum-helpers in the year 2018-19.

4.8 Data Entry on MDM-MIS Web Portal:

MDM-MIS portal captures information on critical indicators of MDMS. The annual data entry module captures master data on availability of kitchen-cum-stores, kitchen devices, number of cook-cum-helpers engaged, mode of cooking etc. The monthly data entry module captures data on number of days Mid Day Meal was served; number of meals served, honorarium paid to cook-cum-helpers engaged, number of children received IFA tablets, number of children screened under Rashtritya Bal Swasthya Karyakram (RBSK) etc. The State of Mizoram has completed 100% Annual and Monthly data entries in the MIS portal.

4.9 Status of implementation of Automated Monitoring System (AMS):

AMS has been put in place for real time monitoring of MDMS. Data on number of meals served on the particular day and reasons if meals not served is being captured from schools with no cost to school head masters/teachers. Out of 2524 schools, daily data has been reported by 1279 schools i.e. 51% schools on Automated Monitoring System. In this regard, email alerts are being sent to all States/UTs on daily basis.

4.10 Centralized kitchens:

No Centralized kitchen has been engaged under MDMS in the State.

4.11 Awareness generation activities:

State has informed that nutritional awareness and food safety awareness activities have been carried out for awareness generation in almost all the district of Mizoram.

4.12 Social Audit:

Social Audit has been conducted in 3 districts so far. State has proposed to cover 1 or 2 more districts under Social Audit during 2019-20.

4.13 Meeting of District Level Steering-cum-Monitoring Committee:

As per the information provided by the State, 8 meetings of District Level Steering-cum-Monitoring Committee under the chairpersonship of the District Collector have taken place against the mandated 84.
