Part-A: General Information

Introduction:

The National Programme of Mid Day Meal in schools, popularly called the Mid Day Meal Scheme (MDMS) is one of the key flagship programmes designed to improve the nutritional status of children in the age group of 6 to 14 years and studying in primary and upper primary classes. The Programme encourages children to come to school and take part in the learning process without worrying for their meal. The Programme was conceived on the basis of the philosophy that "when children have to sit in class with empty stomachs, they cannot focus on learning". The programme in its holistic manner helps to enhance enrolment, attendance and retention of school children while simultaneously contribute to their physical and mental development.

Mid-Day Meal Scheme is a centrally sponsored programme. Central Government provides food grains for the scheme and financing for meeting the cost of food grains, transportation charges and expenses related to the management, monitoring and evaluation of the Scheme. Cooking cost, honorarium to cook cum helpers, cost of construction and repair of kitchen cum stores and procurement/replacement of kitchen utensils are shared between Central and State/UTs on a 60:40 or a 75:25 pattern.

Main objectives of the Scheme

- (i) To increase enrolment, retention and to strengthen the learning abilities of the beneficiaries, especially of children belonging to the weaker and disadvantaged sections of the society.
- (ii) To provide nutritious meal to school children so as to achieve the goal of a healthy mind in a healthy body.
- (iii) To promote and establish a cordial relationship, mutual understanding, healthy friendship and emotional unity among children irrespective of their caste, religion, gender and colour by providing them a common dish and make them eat it at a common place in their respective school premises.

Part-B: Review of Performance in 2019-20 (01.04.19 to 31.03.2020)

2. Based on the information provided by the State Government in its AWP&B 2020-21, the performance during 2019-20 (01.04.19 to 31.03.2020) was reviewed. The major issues in implementation during 2019-20 are summarized as under: -

2.0 Coverage of Institutions

Thus all the eligible institutions in the State have been covered under MDMS.

2.1.3 No. of Meals: Difference between No. of meal to be served (Target) Vs. No. of meals served (Achievement)- PY+U PY (Refer Table 2.7 of the Analysis Sheet).

The number of meals to be served during 01.04.19 to 31.03.2020 = 5398.10 Lakh

The number of meals served during 01.04.19 to 31.03.2020= 4755.88 lakh (88%)

The number of meals served in Alappuzha (79%) and Kollam (76%) are less than the State's average (88%) meals. However, Kozhikode (95%) and Kannur (101%) served more than the average meals. The State may look into the inter-district variations in the meals served.

2.2 FOODGRAINS (PRIMARY + UPPER PRIMARY)

2.2.1 Level of Opening balance as on 01.04.19 :(Refer Table 3.2 of the Analysis Sheet).

The opening balance of food grain with the State as on 01.04.2019 was 6,150.33 MTs (9%) of the annual allocation of food grains of 64.859.83MTs. As per MDMS guidelines, one month's buffer stock is to be maintained by the State.

2.2.2 <u>Level of unspent balance as on 31.03.2020</u>: (Ref*er Table 3.3 of the Analysis Sheet).*

The unutilized food grain with the State as on 31.03.2020 was 8378.75 MTs which is 13% of the annual allocation of 64859.83MTs. As per MDMS guidelines, one month's (10%) buffer stock is to be maintained by the State. However, Kollam (25%) and Alappuzha (22%) had more than average unutilized food grain but Kozhikhode and Kannur had 6% and nil unutilized food grain respectively.

2.2.3 Availability of Food grains: (01.04.19 to 31.03.2020) (Refer Table 3.5 of the Analysis sheet).

The State Government Lifted 58709.50 MTs of food grain from Food Corporation of India. The State had unutilized food grain of 6150.33 MTs with it at the beginning of the year. Thus the total availability of food grain with the State was 64859.83 MTs which 100% of the annual allocation of food grains to the State during 2019-20.

2.2.4 <u>Utilization of food grains: (Refer Table 3.7 of the Analysis sheet)</u>

The State utilize 56481.08MTs (87%) of food grains against the allocation of 64859.83MTs. The Inter-districts variations ranged from 75% in Kollam and 79% in Alappuzha one side and 100% in Kannur. The less utilization is due to closure of schools for 15 working days during March, 2020 on account of COVID 19.

2.2.5 Payment of cost of foodgrains to FCI: (Refer Table 3.9 of the Analysis sheet)

The FCI has submitted bills for Rs. 1761.28 lakh during 2019-20 towards cost of food grains. The State has made payment of Rs.1761.28 lakh (100%) to FCI.

2.3 COOKING COST (PRIMARY + UPPER PRIMARY)

2.3.1 Level of Opening balance as on 01.04.19: (Refer Table 4.1.1 of the Analysis Sheet)

The State had opening balance of Rs. 1530.93 as on 01.04.2019 which is 4% of annual allocation of Rs. 43184.83 lakh. However, Kollam (10%) and Alappuzha (9%) had more than the average opening balance with the State.

2.3.2 Level of closing balance as on 31.03.2020:(Refer Table 4.1.2 of the Analysis Sheet)

The closing balance of Rs.2251.94 lakh (5%) of the total cooking cost allocation of 43184.83 lakh.

2.3.3 Utilization of Cooking cost :(Refer Table 4.5 of the Analysis Sheet).

The State has utilized Rs. 38047.05 lakh (88%) against the allocation of 43184.83 lakh till 31.03.2020. The less utilization is on account of closure of schools for 15 working days during March, 2020 due to COVID 19.

2.4 Reconciliation of utilization and performance during 2019-20 (1.4.19 to 31.03.2020)

2.4.1 <u>Mismatch in utilization of Food grains vis-à-vis cooking cost:</u> (Refer Table – 5.1 of Analysis Sheet)

Ideally the percentage utilization of cooking costs and food grains should tally with each other. The data furnished in the AWP&B reveals that the level in utilization of cooking cost (88%) and food grains (87%).

2.5 <u>Cook-Cum-Helper (PRIMARY + UPPER PRIMARY):</u> (*Refer Table – 6.2 of Analysis Sheet*).

The State has engaged 13,766 cook-cum-helpers (CCH) against PAB approval of 17,673. Thus, 3,907 Cook-cum-helpers are yet to be engaged by the State. Honorarium @ Rs.1000.00 per month per cook-cum-helper is paid for ten months in a year. However, the State is paying honorarium @ Rs. 9400/- per CCH per month against the minimum mandatory State share of Rs.400/-. Thus, Kerala is making additional contribution of Rs. 9000/- per CCH per month from own resources over and above the minimum mandatory share. The State has proposed to engage 17,673 CCH during 2020-21.

The State had Rs.197.04 as opening balance on 01.04.2019. An amount of Rs. 13378.24 lakh was released for payment of honorarium to CCH. The expenditure is Rs.13340.84 lakh (75%) against the allocation of Rs.17,673 lakh.

2.6 <u>Utilization of MME</u>(Refer Table – 7.2 of Analysis Sheet)

The annual allocation for MME during 2019-20 isRs. 570.74 lakh. There was opening balance of Rs. 19.06 lakh with the State on 01.04.2019. Rs 551.68 lakh were released to the State. Thus the State had total availability of Rs. 570.74 lakh with it during 2019-20 .The State has utilized Rs. 394.10 lakh (69 %) of the annual allocation.

2.7 <u>Utilization of Transportation Assistance</u>(Refer Table – 8.2 of Analysis Sheet)

The State had nil opening balance on 01.04.2019. The annual allocation for Transport Assistance during 2019-20 is Rs 972.90 lakh. The State had lifted 58709.50MTs of food grain from FCI during the year. The State is paying transportation charges @ 2150 per MT (Rs.1500 from Central Share and Rs.650 State Share) Thus, transportation assistance @ 2150 per MT for carrying the food grains to schools is 1262.25 lakh. The State has incurred the expenditure of Rs. 1262.25 lakh (100%) on transportation of food grains from FCI godowns to schools.

2.8 Construction of Kitchen-cum-stores (Reference Table -9.1.3 of Analysis Sheet)

Central assistance of Rs. 15202.81 lakh has been released from 2006-07 to 217-18 for construction of 5481 Kitchen-cum-Stores. The State has constructed 2450 (45 %) kitchen-cum-Stores and utilized central assistance of Rs.2544.55 lakh. The construction work is 'in-progress' in the remaining 3031 kitchen-cum-stores which were sanctioned during 2017-18. The State may ensure that the construction of 3031 kitchen-cum-stores is completed by 31.12.2020.

2.8 A Repair of Kitchen-cum-stores:

The State has not proposed to repair the kitchen-cum-stores.

2.9 Procurement of Kitchen devices (Reference Table -9.2.3 of Analysis sheet)

The central assistance of Rs617.90lakh has been released from 2006-07 to 2009-10 towards procurement of 12358 units of kitchen devices @ Rs.5,000 per school. The kitchen devices have since been procured for all the schools and central assistance of Rs.617.50 lakh has since been utilized.

The central assistance of Rs. 73.65 @ Rs.5,000 per school, was released to the State for the replacement of kitchen devices in 1473 schools. These kitchen devices for these schools have since been replaced.

4. Fund Flow

Funds relating to mid-day-meal are being transferred from head office to respective District Education Officer's bank accounts through RTGS and further the funds are transferred to school level through District Authorities.



^{*} General Education Department issues administrative sanction to the Director, General Education (SNO) to utilize the entire budgetary provision for MDMS. The said sanction is normally issued in the first week of June and August, every year. Within a week, Director, General Education places the funds via treasury allotment to the Deputy Directors of 14 districts.

It would be observed that there was delay of 1.5 months at State level for the release of funds to district. The date of release of funds by district to schools has not been indicated in AT-2 A relating to fund flow.

5. Management Structure



One Programmer and the Office Attendant at the State Level and all the data entry operators working at the State, district and sub-district (block) levels are engaged on daily wage basis. One Programmer at the State Level is on contract basis. The wages of daily and contract employees are paid from MME Fund.

6. Capacity Building of Cook-cum-helpers.

All the 13,776 Cook-cum-helpers (CCH) have been provided one day training at the State Food Craft Institute in each district by 420 Master Trainers (30 for each district). Hands on training was provided to the CCH on cooking. The training modules included hygiene, cleanliness, nutrition, preservation of food articles, maintenance of cleanliness in the kitchen and its store, procuring good quality food articles and their safe storage. Awareness on MDMS was also included as a topic in the training module.

7. Grievance Redressal Mechanism

A Grievance Redressal Cell has been constituted at the State Level under the supervision of Director, General Education. One dedicated landline number and an email id has been provided for lodging thecomplaints/suggestions. Grievance Redressal Cells are constituted at district levels also. The phonenumber of the district grievance cell has to be mandatorily displayed in notice boards inschools.

At the district level, the complaints are attended by the district nodal officer or the Noon Feeding Supervisor. The complaints that can be resolved at the district level itself will be redressed within 3 to 4 days. Otherwise, they will be brought to the attention of State level. The status of complaints at the district and block levels and their redressal are to be reported to Director, General Education in separate Format once in every month.

Altogether 94 complaints were received during the year 2019-20. These related to food grain issues (8), Mis-appropriation of funds (19), non-payment of honorarium to CCH (7), Quality of meal served (15), use of firewood (3), Hygeiene and cleanliness (7) and Corruption related (20). Of these, 73 cases have been resolved. Of the remaining twenty one cases, two cases are pending in Courts while action initiated in 19 cases.

8. Testing of Meal by accredited labs

During the year 2019-20, food samples were collected from 7186 schools out of the 12324 schools and tested for microbiological parameters at CEPCI Laboratory & Research Centre. Same number of water samples was also collected for testing along with the food samples.

Seven food samples out of the 7186 samples tested did not meet the norms. The issue was with the water supply system in all these 7 cases. Schools, from where these food samples were collected depend on well water for drinking and cooking purposes. The water samples from these schools when tested contained the presence of the bacteria, E.Coli . The water system was found to be contaminated. The wells were cleaned under the supervision of school PTAs as per the guidelines given by CEPCI Laboratory.

Water samples from these seven schools will be collected on a priority basis before the opening of schools in order to ensure it is safe to be used for drinking and cooking purposes.

9. Community participation:

- Tasting of meal: Members of Mother PTA, SMC members and teachers ensure the quality of food served to the students. Representatives of teachers, mother PTA and SMC taste the food and ensure its quality before it is served to children. A separate Register is maintained at schools to record the remarks/opinions of the members of SMC and parents who taste the quality of food. The Register is regularly inspected by the Officers at the block level.
- ii) **Community monitoring**: Kerala State has very strong Parents Teacher Association, Mother-Teachers Associations and the member of these association are invariable present in the school at the time of preparing and serving of meals to the children. They also taste the meals before it is served to the students.
- iii) Contributions by community under Tithi Bhojan: During 2019-20, 5255118 full meals at an estimated cost of Rs.5266.11 lakh were served to the children in 12324 schools during the festival seasons such as Onam, Ramadan etc. The special meal consists of 14 to 15 additional nutritive side dishes and dessert items such as 'Kerala Payasam", etc. The average cost/value of one such meal is about 100 rupees. Additional food items were also served in 12324 schools at a value of Rs. 26.28 lakh.Besides, 5179 schools received in-kind contribution from the community. Such the contributions was received in the form of kitchen utensils, eating plates, steel glasses for drinking water, water purifiers, refrigerators, mixer grinders, additional stoves, vegetable chopping boards, knives, disinfectants, washing soaps, hand wash, gloves, aprons, etc. Contributions are received from School PTA, Community members, Charitable Organizations, Rotary Clubs, Residential Associations, Alumni Associations, etc.

10. Social Audit:

The State Government has assigned the conducting of Social Audit in 20 schools each in Allapuzhaand Wayanad to Integrated Rural Training Centre (IRTC) which is a Wing of Kerala Shastra SahityaParishad, at an estimated expenditure of Rs. 10.11 lakh. The Memorandum of Agreement has been signed by the State Government with IRTC. The process for Social Audit had been started by IRTC but had to be stopped due to COVID 19.

11. Monitoring & Supervision

The Mid Day Meal Scheme is supervised and monitored at school level by the School Mid Day schools under the chairmanship of PTA President is its Chairman and Headmaster of the schools is the Member Secretary/Convener. The Committee also comprises of SMC Chairman, MPTA President/Member, Local Ward Member, representatives of teachers, representatives of parents of children belonging to SC/ST and minority communities and one representation each from students and the cook-cum-helpers. The MDM Committee has to be mandatorily convened at least once in every month. The Committee reviews the existing Menu and makes changes, if necessary taking into account the advice of nutrition experts and suggestions from students. The Committee gives special consideration to include locally available ingredients/items in the menu.

12. RashtriyaBalSwasthyaKaryakaram:

The State may ensure that health check up of all the school children is completed under RBSK and IFA and de worming tablets are given to the children in convergence with the Ministry of Health & Family Welfare.

13. School Nutrition Gardens:

School Nutrition Gardens have been set up in 6525 schools. The State proposes to set up kitchen gardens in 9025 schools during 2020-21. Nutrition Gardens are set up in schools by school PTA, SMC and Eco Clubs. Schools receive financial assistance from State Agricultural Department and from LSG institutions to set up nutrition gardens

The PAB-MDM had approved setting up of School Nutrition Gardens in 12341 SNG @ Rs 5000 each, in its meeting held on 10th May, 2019 at a cost of Rs. 617.05 lakh (Rs. 370.23 lakh Central share and Rs. 246.82 lakh State share).

The State has informed that though it proposed for flexi funds in AWP&B 2019-20 for setting up kitchen gardens in 5124 schools and for maintaining the existing ones at 7217 schools @ Rs.5000 per school in 60:40 fund sharing ratio, the proposal could not be proceeded with as the State was reeling under financial crisis during the previous year.

The State may set up/maintain 9025 SNGs during this year in all schools and grow vegetables, fruits grown in these SNGs.

14. Non-Government Organization (NGO):

No NGO has been engaged by the Government of Kerala for supply of meals to the children under Mid Day Meal Scheme.:

15. Cooking Competition:

The State has not organized cooking competitions at various levels i.e. Block level, District level and State level in schools for promoting variety menu. The State may organize cooking competitions during 2020-21. The nutritionists will examine the recipes to ensure compliance with nutrition standards as laid down in Mid-Day Meal guidelines. The children may be included as judges in these competitions because they are the ones for whom the meal is being cooked. The expenditure for these activities will be met from MME component.

16. Supplementary nutritional items (milk, egg etc.):

One of the primary objectives of Mid Day Meal Scheme is to improve the nutritional status of children through supplementary nutrition. However various studies have shown that malnutrition and micronutrient deficiencies are rampant among school going children. Micronutrient

deficiency (such as that due to deficiency of Vitamin A, Iron, etc) is emerging as a major public health problem in Kerala which needs to be addressed through various interventions such as dietary diversification.

To further meet the nutritional requirements of children and thus to reduce the rate of malnutrition and micronutrient deficiencies among them, State of Kerala has decided to introduce seasonal fruits viz. banana, guava, mango, papaya, custard apple, orange, jackfruit, citrus fruits, gooseberries, etc. as an additional food item in MDM menu as a new intervention operative from 2020-21 academic year onwards. This intervention is proposed as a centrally sponsored scheme under the 5% Flexi Funds wherein Centre and State Governments will be sharing the expenses on a 60:40 cost sharing basis. The new intervention is proposed to be introduced for all the 26,27,559 school children from the date on which 12,324 schools reopen after mid summer vacations. The total requirement of funds would be Rs.5255.12 lakh @ Rs.5 per fruit per child once in a week. Rs. 1439.74 lakh would be utilized from flexi fund.

17. Awareness generation activities:

State carried out IEC activities at State, District and school level. Manuals, handbooks, flipbooks, brochures and albums have been printed. Poster campaign, quiz competitions, rallies, health and Nutrition awareness camps were organized. An expenditure of Rs. 18.44 lakh has been incurred on these activities.

18. Use of LPG:

LPG is used as mode of fuel in all schools. .

19. Meeting of District level Steering cum Monitoring Committee:

As per the information provided by the State, 33 meetings of District Level Committee under the chairpersonship of the District Collector were held against the mandated 168 meetings. The State may advise their district authorities to convene DLC meetings on monthly basis so as to review the implementation of MDMS and take corrective measures wherever necessary for improving the implementation of the scheme.

20. Use of Millets / Coarse grains:

Millets are a rich source of protein. Therefore, use of millets under Mid Day Meal may be encouraged.
