### **Good Practices**

- State has provided foodgrains and cooking cost as Food Security Allowance for 90 days (51 days closure of schools + 39 days summer vacation) as COVID response.
- 2) State is providing additional contribution of Rs.400/- per cook-cum-helper.
- 3) State is providing additional contribution of Rs 0.45 in primary and Rs 0.65 in upper primary, per child per day in Cooking Cost.

#### Issues:

- 1) More than 2 months delay in release of funds from State to districts.
- 2) Less coverage of 18 working days.
- 3) School Nutrition Gardens developed only in 11,117 (20%) schools.
- 4) Delay in construction of 24661 kitchen-cum-stores (construction is in progress since 2012-13).
- 5) Social Audit not conducted during 2019-20.
- 6) Testing of meals not done during 2019-20.

### **Part-A : General Information**

#### Introduction:

Mid-Day Meal is a flagship programme of Govt. which caters to the supplementary nutritional needs of school going children. It is the largest school feeding programme of the world. In Odisha 57,684 kitchens are run every day to feed 46,41,593 children. Mid Day Meal programme is a scheme not only to drive out class room hunger but also to build the nation by providing nutrition to the 09.46 crore children who are the future of India.

#### 1.1 Briefhistory

- 1995: Introduced in 2408 blocks to provide 100 grams foodgrains per child/ school day under National Program for Nutrition Support to Primary Education.
- □ 1997-98: Extended in 1997-98 to all primary schools.
- 2001: On November 28, 2001 the Supreme Court of India made it mandatory for the State Government to provide cooked meal instead of dry ration.
- □ 2002-03: Extended in 2002-03 to cover EGS/AIE centres.
- 2004: Supreme Court Orders in P.U.C.L case for providing hot cooked meal to all the schools fully funded by the Centre.
- 2006-07: Provision of Central assistance for kitchen-cum-store and kitchen devices @ Rs. 60,000 per unit and Rs. 5000 per school respectively.
- □ 2007-08: Extended to upper primary.
- □ 2009-10: Revision of Scheme
  - Food norm for upper primary.
  - Separate provision for honorarium to CCH.
  - Revision of norms for kitchen-cum-store and transport assistance for special category States (11).
- □ 2010-11: Decentralization of payment of cost of food grains to districts w.e.f. 1.4.2010.
- October, 2010: Inclusion of NCLP schools under MDMS.
- November, 2011: Provision at par with upper primary for NCLP schools.
  - July, 2012: Revision of Cooking cost by 7.5%
- □ 2013- MDM covered under NFSA Act, 2013
- 2014- MDM covered under Odisha Mid Day Meal Rules 2016
- 2016 Mid Day Meal Fortification notified by FSSAI

# 2.1.3 <u>No. of Meals</u>: Difference between No. of meal to be served (Target) Vs. No. of meals served (Achievement)- PY+U PY (Ref*er Table 2.7 of the Analysis Sheet).*

The number of meals to be served during 01.04.19 to 31.12.2019 = 7310.77 Lakh

The number of meals served during 01.04.19 to 31.12.19 = 5911.25 lakh (81%)

The number of meals served in Cuttak&Kandhmal was 79% and 66% in Khurda which 10% and 23% less than the average of 81% meals served till December, 2019. Serving of less number of meals in the above districts indicates issues relating to implementation of the scheme in the above districts.

## 2.2 FOODGRAINS (PRIMARY + UPPER PRIMARY)

## 2.2.1 Level of Opening balance as on 01.04.19 :(Refer Table 3.2 of the Analysis Sheet).

The opening balance of food grain with the State as on 01.04.2019 was13360.93 MTs which is 11% of the allocation of food grains during 2019-20 is 124232.81 MTs. As per MDMS guidelines, one month's (10%) buffer stock is to be maintained by the State. However, Ganjam and Rayagarha districts did not maintain any buffer stock of food grains. On the contrary, Boudh, Jharsuguda, Kandhmal andSonepur had buffer stock of 22%, 25%, 35% and 21% respectively. Thus, problems in supply chain management of foodgrains observed at the beginning of FY were not resolved by the State.

# 2.2.2 <u>Level of unspent balance as on 31.12.2019 :</u> (Ref*er Table 3.3 of the Analysis Sheet).*

The unutilized food grain with the State as on 31.12.2019 was 13360.93 MTs which is 11% of the annual allocation of 124232.81MTs. As per MDM guidelines, As per MDMS guidelines, one month's (10%) buffer stock is to be maintained by the State. However, Ganjam and Rayagarha districts did not maintain any buffer stock of food grains. On the contrary, Jharsuguda, Kendrapada,Sambalpur and Sonepur had buffer stock of 25%, 35%, 23% and 25% respectively. Thus, it may be observed that there are problems relating to supply chain management of foodgrains.

# 2.2.3 <u>Availability of Food grains: (01.04.19 to 31.12.19</u>)(*Refer Table 3.5 of the Analysis sheet).*

The State Government Lifted 76861.44 MTs of food grain from Food Corporation of India. The State had unutilized food grain of 13360.93 MTs with it at the beginning of the year. Thus the total availability of food grain with the State was 90222.37 MTs which 73% of the annual allocation of food grains to the State during 2019-20.

# 2.2.4 <u>Utilization of food grains: (Refer Table 3.7 of the Analysis sheet)</u>

The State utilized 70434.02MTs (57%) of food grains against the allocation of 124232.81MTs.The utilization of food grains was less in Kandhmal(50%) and Khurda (42%) which indicates problems in the implementation of the scheme in these districts in particular.

# 2.2.5 Payment of cost of foodgrains to FCI: (Refer Table 3.9 of the Analysis sheet)

The FCI has submitted bills for Rs. 2305.84 lakh during 2019-20 towards cost of food grains. The State has made payment of Rs.2305.84 lakh (100%) to FCI.

# 2.3 COOKING COST (PRIMARY + UPPER PRIMARY)

## 2.3.1 Level of Opening balance as on 01.04.19: (Refer Table 4.1.1 of the Analysis Sheet)

The State had opening balance of Rs. 12440.25lakh as on 01.04.2019 which is 20% of annual allocation of Rs. 61109.54 lakh.

## 2.3.2 Level of closing balance as on 31.12.19 :(Refer Table 4.1.2 of the Analysis Sheet)

The closing balance of Rs.29001.80 lakh (47%) of the total cooking cost allocation of 61109.54 lakh. The closing balance of cooking cost with Jharsuguda (52%), Kandhmal (54%) and Khurda (62%) was more than the average closing balance of 47% on 31.12.2019. This indicates the problems in the implementation of the scheme in these districts.

## 2.3.3 <u>Utilization of Cooking cost :</u>(Refer Table 4.5 of the Analysis Sheet).

The State has utilized Rs. 34511.23 lakh (56%) against the allocation of 61109.54 lakh till 31.12.2019. The State should have utilized at least 75% of the annual allocation by the end of 3rd quarter. Less utilization against the expected utilization of cooking cost indicates either delay in the release of cooking cost or improper implementation of the scheme. The utilization of cooking cost was less than the average utilization in Kandhmal (50%) and Khurdha (42%).

# 2.4 Reconciliation of utilization and performance during 2019-20 (1.4.19 to 31.12.2019)

# 2.4.1 <u>Mismatch in utilization of Food grains vis-à-vis cooking cost: (Refer Table – 5.1 of</u> *Analysis Sheet)*

Ideally the percentage utilization of cooking costs and food grains should tally with each other. The data furnished in the AWP&B reveals that the level in utilization of cooking cost (56 %) and food grains (57 %).

# 2.5 <u>Cook-Cum-Helper (PRIMARY + UPPER PRIMARY)</u>: (*Refer Table – 6.2 of Analysis Sheet).*

The State has engaged 1,15,479 cook-cum-helpers (CCH) against PAB approval of 1,45,522. Thus, 30,043 Cook-cum-helpers are yet to be engaged by the State. Honorarium @ Rs.1000.00 per month per cook-cum-helper is paid for ten months in a year. This honorarium is shared between the Centre and the State in 60:40 ratio. However, States can contribute more from their own resources. Odisha is making additional contribution of Rs 400/- per CCH per month from own resources over and above the minimum mandatory share. The State has proposed engage 145522 CCH during 2020-21.

The State had nil opening balance on 01.04.2019. An amount of Rs.19407.95 lakh was released for payment of honorarium to CCH. The expenditure is Rs. **11217.80** lakh (55%).

# 2.6 <u>Utilization of MME(Refer Table – 7.2 of Analysis Sheet)</u>

The annual allocation for MME during 2019-20 is Rs.1272.23 lakh. There was opening balance of Rs. Nil with the State on 01.04.2019. Rs1272.23 lakh were released to the State. Thus the State had total availability of Rs.1272.23 lakh with it during 2019-20. The State has utilized Rs. 824.14 lakh (65 %) of the annual allocation.

# 2.7 <u>Utilization of Transportation Assistance</u>(*Refer Table – 8.2 of Analysis Sheet*)

The State had 207.51 lakh opening balance on 01.04.2019. The annual allocation for Transport Assistance during 2019-20 is Rs.1663.08 lakh. The State had lifted 76861.44 MTs of food grain from FCI during the year. Thus, transportation assistance @ 150 per quintal for carrying the food grains to schools is Rs.1152.92 lakh. The State has incurred the expenditure of Rs.676.17 lakh (41%) on transportation of food grains from FCI godowns to schools.

# 2.8 <u>Construction of Kitchen-cum-stores</u> (*Reference Table -9.1.3 of Analysis Sheet*)

Central assistance of Rs.40579.81 lakh has been released from 2006-07 to 2009-10 for construction of 69,152 Kitchen-cum-Stores. The State has constructed 44.491 (64%) kitchen-cum-Stores. The construction work is 'in-progress' in the remaining 24,661(36%) kitchen-cum-stores. The State may be advised to complete the construction of 24,661 kitchen-cum-stores, by 31<sup>st</sup> March, 2019.31.12.2020.

#### 2.8 A Repair of Kitchen-cum-stores :

The State of Odisha has proposed repair for 21,007 kitchen-cum-stores with an outlay of Rs 2100.70 lakh, comprising Rs 1260.42. lakh as central share and Rs 840.28 lakh as State share. The above proposal has already been approved by PAB-MDM in its meeting held on 6<sup>th</sup> June, 2019.

## 2.9 Procurement of Kitchen devices (Reference Table -9.2.3 of Analysis sheet)

Central assistance of Rs 3319.15 lakh has been released from 2006-07 to 2009-10 towards procurement of 66383 units of kitchen devices. The State has reported that allthe units of kitchen devices have been procured. Central Assistance of Rs3394.15 lakh was further released during 2013-14 to 2016-17 for the replacement of 67,883 units of kitchen devices, against this the State has replaced Kitchen devices in all the 67,883 schools.

The State has proposed procurement of kitchen devices for 190 new schools and replacement of 54,228 units of kitchen devices linked to enrolment as follow:

The above proposals for the procurement of kitchen devices for 190 schools and replacement of kitchen devices in 54,228 schools has already been approved by PAB-MDM in its meeting held on 6<sup>th</sup> June, 2019. Therefore, fresh approval of PAB during 2020-21 may not be required.

It would be observed that there was delay of 2-3 months at State level for the release of funds to district. The date of release of funds by district to schools has not been indicated in AT-2 A relating to fund flow.

#### 5. Management Structure

The Management Structure consists of State Level Steering-cum-Monitoring Committee (SLSMC) headed by the Development Commissioner-cum- Additional Chief Secretary,

Government of Odisha. Principal Secretary/Secretary, School & Mass Education Department is the next level below the SLSMC and is assisted by the State Nodal Officer-cum-Director, Mid Day Meal

SNO is assisted by District Education Officers and Block Education Officers in the implementation of the scheme. Each DEO/BEO has been provided Data Entry Operators under the Scheme.

The School Management Committee is the ground level unit for the implementation of the Scheme at the grass root level.

# 6. Capacity Building of Cook-cum-helpers.

No training has been provided to Cook-cum-helpers during 2019-20. It is relevant to mention that preparation of hygienic and wholesome meal is contingent upon the knowledge and skills of the engaged for providing meals in schools. As such cook-cum-helpers are the pillars of scheme. Therefore, it is imperative that they are provided trainings from the Institutes of Hotel Management, Food Craft Institutes to upgrade their skills about nutrition, cooking process, health and hygiene.

# 7. Grievance Redressal Mechanism

A 24 hour toll free no. at telephone no.1800-345-6722 has been installed at the State level. Complaints received are recorded in the registers and action is taken within three days to dispose it off. No complaint is pending in the State.

221 complaints were received by the State during 2019-20. 56 of them related to food grain related issues, 8 for delay in transfer of funds, 4 against Centralized Kitchens, 124 for quality and quantity of food grains, 18 to hygiene and 11 for other issues. Action has been taken on all these complaints.

# 8. Testing of Meal by accredited labs

No Food samples has been got tested from the FSSAI or recognized labs. As per Mid Day Meal Rules, 2015 the State Food and Drugs Department is to take food samples randomly from the schools and send them for testing by the accredited or recognized laboratory. The State Government may coordinate with their Food & Drugs Department for ensuring that the food samples are collected from the schools at regular interval for testing whether the conform to prescribed calorific and nutrition norms.

## 9. Community participation:

i) **Tasting of meal**: Mid Day Meal prepared in schools is tasted by Teachers, parents of the children and cook-cum-helpers. All the schools maintain the taste register in which feedback/remarks are recorded after tasting of meals. Parents roster has been maintained in 52089 schools (94%) for supervision of mid day meal on rotation basis..

- ii) **Community monitoring**: Parents roster has been maintained in 52089 schools (94%) for supervision of mid day meal on rotation basis.
- iii) **Contributions by community under TithiBhojan:** The concept of TithiBhojan for community participation under Mid Day Meal is not prevalent in the State. As such no contribution has been received from the community under Mid Day Meal Scheme.

The State may encourage the community participation in Mid Day Meal Scheme to celebrate important events such as birth of a child in the family, success in examination, anniversaries etc wherein community may provide either full mid day meal or additional nutrition items in the school for the children or the community may contribute in-kind also by donating computers, eating plates, ROs, fans etc. This will generate sense of ownership of the scheme amongst the community and also enable it to supervise and monitor the mid day meal more closely.

## 10. Social Audit:

Social Audit has not been conducted by the State so far. It is relevant to mention that PAB-MDM had advised the State in its meeting held on 6<sup>th</sup> June, 2019 that Social Audit covers the issues of equity and equality along with expenditure in programme implementation. State was further informed that under the provisions of section 28 of National Food Security Act, 2013 Social Audit of the scheme is mandatory. As per the MDM guidelines also, it is mandatory to conduct Social Audit in at least 20 schools in all districts. The Social Audit Units (SAU) set up under MNREGS, may be actively involved in conducting Social Audit of MDM in all districts.

The State may be take necessary action for conducting social audit as per the above decision of PAB-MDM and share the findings of Social Audit with Department of School Education and Literacy, Ministry of Human Resource Development, Government of India.

#### 11. Monitoring & Supervision

The Mid Day Meal Scheme is supervised and monitored at school level by the School Management Committee, Mother's Committee. The Block level Steering-cum-monitoring Committee and District Level Committee under the Chairpersonship of District Magistrate monitors the Scheme in its monthly meetings. Besides, quarterly meetings are held under the chairmanship Senior most Member of Parliament (Lok Sabha) of the district to monitor the scheme.

#### 12. RashtriyaBalSwasthyaKaryakaram:

## 13. School Nutrition Gardens:

School Nutrition Gardens have been set up in 11117 schools. The setting up of kitchen gardens is in progress in 4553 schools. The State proposes to set up kitchen gardens in 13,727 schools during 2020-21.

The PAB has already approved the setting up of SNGs in 43,000 schools, in its meeting held on 6<sup>th</sup> June, 2019 with assistance of Rs.2150.00 lakh (Rs.1290.00 lakh as Central Share and Rs.860.00 lakh of State Share). The letter to conveying the approval of MHRD to this effect has since been issued to the State Government in March, 2020. The State may take necessary action for setting up of the SNGs approved during 2019.

The State may also follow the advice of PAB-MDM during its meeting held on 06<sup>th</sup> June, 2019 that the whole vegetables, fruits grown in the SNGs may be consumed under mid day meal including some of the parts like stem (banana, bottle gourd, pumpkin) leaves (coriander, mint, spinach), flower (pumpkin flower, morringa). State may have convergence with the line department viz. KrishiVigyan Kendra, Department of Agriculture,/Horticulture, Food & Nutrition Board, State Agriculture Universities etc. for setting up of SNGs. The State may have convergence with Mahatma Gandhi Rural Employment Guarantee Scheme(MNREGS) of Ministry of Rural Development for constructing boundary walls around these SNGs, leveling of the ground.

## 14. Non-Government Organization (NGO):

State has engaged the Centralized Kitchens of two Trusts viz. Akshay Patra and Manna Trust 7 districts (Cuttak, Ganjam, Keonjhar, Khurda, Nayagarh, Puri and Sundergarh) and 4 NGOs in six districts for serving mid day meal in different cities as mentioned below :

# 15. Cooking Competition:

The State has not organized cooking competitionsat various levels i.e. Block level, District level and State level in schools for promoting variety menu. The State may organize cooking competitions during 2020-21. The nutritionists will examine the recipes to ensure compliance with nutrition standards as laid down in Mid-Day Meal guidelines. The children may be included as judges in these competitions because they are the ones for whom the meal is being cooked. The expenditure for these activities will be met from MME component.

# 16. Supplementary Nutrition through Flexi funds:

The State informed that they are providing egg or fruit to the children twice a week on Wednesday and Saturday under Mid Day Meal Scheme. During 2019-20 flexi fund to the tune of Rs.2150.00 lakh @Rs.5000/- each for 43,000 schools has been earmarked. Rest 13,727 schools to be adopted for kitchen garden. So this year flexi fund of Rs. 3804.93 lakh can be considered for utilized in supplementary nutrition over and above the existing provisions in provision of additional egg, milk, millet based item to the school going children in all districts.

## 17. Awareness generation activities:

State carried out IEC activities at State, District and school level. Audio videos have been developed and Mid Day Meal Awareness Mela was organized. An expenditure of Rs. 1.20 lakh has been incurred on these activities.

## 18. Use of LPG:

LPG is used as mode of fuel in 32210 (58%) schools. It was observed that 19912 (36%) schools are using fire wood. The State was advised to provide LPG connection in all the schools.

## **19.** Meeting of District level Steering cum Monitoring Committee:

As per the information provided by the State,436 meetings of District Level Steering cum Monitoring Committee under the chairpersonship of the District collector have taken place against the mandated 360 meetings. Whereas DLC meeting has been held regularly in each district, a few districts viz. Dhenkenal, Jharsuguda, Kalahandi, Kendrapada,Khurda, Nayagarh, Puri, Sambalpur and Sonepur have convened less than 12 meetings in a year. The State may advise their district authorities to convene DLC meetings on monthly basis so as to review the implementation of MDMS and take corrective measures wherever necessary for improving the implementation of the scheme.

## 20. Use of Millets / Coarse grains:

Millets are a rich source of protein. Therefore, use of millets under Mid Day Meal may be encouraged..
