Subject: Third Review Mission for Mid Day Meal Scheme

Sir / Madam,

As you may be aware, the Ministry of HRD's Mid Day Meal Scheme is the largest school feeding programme in the world reaching out to about 12 crores of children in more than twelve lakhs primary and upper primary schools (Government, Government Aided and Local bodies), National Child Labour Project (NCLP) schools EGS/AIE centres and Madrasas and Maqtabs supported under Sarva Shiksha Abhiyan. A programme of such a large scale and magnitude of Mid Day Meal requires close monitoring and evaluation at all levels. Government of India had, therefore, decided to review the implementation of the programme in all its aspects through a Review Mission which will also provide suggestions for improvement 2009-10.

2. The Review Mission would visit about 10 schools in 2 districts in each of the eight States viz. Kerala, Madhya Pradesh, Maharashtra, Manipur, Orissa, Tamil Nadu, West Bengal and Uttarakhand. The Review mission for each State will comprise of four members i.e. one from Government of India, one from State Government i.e. Director of MDM Scheme, one from International organization (UNICEF) and one from office of Supreme Court Commissioner. One of the districts to be visited by the Review Mission shall be decided by the State and other by the Govt. of India. The mission will be lead by the Director, MDM of the Govt. of India.

The Mission will complete the following tasks:

- (i) Review the system of fund flow from State Government to Schools/cooking agency and the time taken in this process.
- (ii) Review the management and monitoring of the scheme from State to School level.
- (iii) Review the implementation of the scheme with reference to availability of food grains, quality of MDM, regularity in serving MDM as per approved norms and mode of cooking.
- (iv) Role of Teachers,
- (v) Convergence with School Health Programme (SHP) for supplementation of micronutrients and health checkups and supply of spectacles to children suffering from refractive errors.
- (vi) Creation of capital assets through kitchen-cum-store/kitchen devices
- (vii) Appointment of Cook-cum-Helpers for preparation and serving of meal to the children
- (viii) Availability of dedicated staff for MDM at various levels
- (ix) Review the maintenance of records at the level of school/cooking agency.
- (x) Review the availability of infrastructure, its adequacy and source of funding.
- (xi) Review of payment of cost of foodgrains to FCI by the districts
- (xii) Review the involvement of NGOs/Trust/Centralized kitchens by States/UTs Government in implementation of the Scheme.
- (xiii) Management Information System (MIS) from school to block, district and State Level to collect the information and disseminate it to other stakeholders
- (xiv) Assess the involvement of Community' in implementation of MDM scheme

and give suggestions for improvement in the implementation of the programme.
