4. Challenges in implementation of MDMS in Jammu & Kashmir

- I. Delay in the release of Ad hoc funds (more than one month) from UT MDM Authority to schools.
- II. Less than the minimum 10% mandatory UT's share released to the schools during 2020-21. UT's shared was only 5% in cooking cost and 6% in honorarium to CCH.
- III. Construction of 4697 units of Kitchen-cum-Stores not started as yet. (776 units sanctioned during 2006-07 & 2007-08 @0.60 lakh per unit and 3921 units sanctioned during 2011-12 as per SOR.)
- IV. Yet to procure 1311 units of New Kitchen Devices sanctioned during 2014-15.
- V. Yet to constitute dedicated management structure / manpower in the UT Administration for MDMs in UT/District/Block levels.
- VI. Social Audit not conducted in the UT.
- VII. UT not conducted testing of food samples.
- VIII. Less coverage of children (16%) under Rastriya Bal Swasthaya Karyakram (RBSK), Deworming tables distributed to 6% children and IFA tablets not distributed.
 - IX. Only 3076 (14%) Schools having School Nutrition Garden. State has furnished Annual data for 87% Schools and Monthly data for 63% school for FY 2018-19
 - X. Only 39% Schools reporting under Automated Monitoring Systems (AMS),
 - XI. No Emergency Plan, Detailed MME Plan developed by State.
- XII. No Management for time bound Annual and Monthly Data Entry by State.

5. Best Practices being followed in the State for effective implementation of the scheme: -

- I. Funds is being E-transfer from UT head quarter to District /Block /School
- II. Honorarium of cook-cum-helpers is paid through e-transfer to their bank accounts
