**PAB – ASSURANCES : 2016-17**

# Chhattisgarh

- i. Steps would be taken to check the consistent decline in the enrolment.
- ii. The cooking cost for upper primary would be revised to Rs.5.78 per child per day w.e.f 01.07.2015.
- iii. Honorarium would be e-transferred in to the bank of cook-cum-helpers every month.
- iv. LPG connections would be provided in 40% of the schools during 2016-17.
- v. All the kitchen-cum-stores under construction or for which construction is yet to start, would be constructed by December, 2016.
- vi. The pending kitchen devices would be provided in schools by June, 2016.
- vii. School Health Programme would be strengthened.
- viii. Testing of samples of meal from Government recognized laboratories or the laboratories of Home Science Colleges.
- ix. Rolling out the automated system of monitoring within the prescribed timelines.
- x. Installation of multiple tap facility in all the schools.

# Jharkhand

- Increase the coverage of children against enrolment.
- Payment of the pending bills of the FCIs in a time bound manner.
- State to surrender 4037 kitchen and submit fresh proposal for these on the basis of plinth area norm and State schedule of rate.
- LPG connections in 33115 institutions in a phased manner.
- Opening of bank accounts of 64033 cook cum helper.
- Submission of the ATN on complaints within 10 days after the PAB meeting.
- Better convergence with health department.

# Haryana

- To take necessary steps to enhance the coverage of enrolled children.
- E-transfer of funds to all the remaining cook cum helpers and payment of honorarium to cooks in their bank account.
- Complete construction of all remaining 1697 kitchen cum store by December 2016.
- To do the health check-up of all the enrolled children twice a year.
- To look into the issue of delay in release of fund (3-4 months) State to District Level.

# Madhya Pradesh

- Steps would be taken for the timely release of central assistance to the schools/implementing agencies.
- Supply chain management of food grains would be streamlined to ensure timely and equitable availability of food grains in all schools.
- At least 60% of the schools will have LPG connections during 2016-17.
- Necessary steps would be taken to improve coverage of children against enrolment.
- The accounts of all cook-cum-helpers would be opened and their honorarium to be e-transferred in to their accounts.

# Contd. Madhya Pradesh

- All the sanctioned kitchen-cum-stores would be constructed by December, 2016.
- Payment of food grains pending bills for Rs.959 lakh would be made to NAN before March, 2016.
- Action Taken Note on six complaints forwarded by the MHRD to State would be submitted by end of March, 2016.
- Multi-tap hand wash facilities would be provided in all schools during 2016-17.
- The automated monitoring system for monitoring mid day meal scheme would be rolled out within the prescribed timelines.

# Punjab

- The fund flow system would be streamlined for ensuring timely release of central assistance to the implementing agencies.
- The State would take remedial measure to check the quarter wise decline in the coverage of children in upper primary classes.
- DLC meetings would be convened on quarterly basis.
- Social audit would be up scaled in all districts of the State during 2016-17.
- Necessary action would be taken to roll out the automated monitoring system within the prescribed timelines.

# Rajasthan

- Fund flow system to be streamlined to ensure timely release of funds.
- The bank accounts of all cook-cum-helpers would be opened and honorarium would be e-transferred in to their bank accounts.
- LPG connection would be provided in the remaining schools during 2016-17.
- To take remedial measure to check the quarter wise decline in the coverage of children.
- Food grain management would be streamlined.
- All the sanctioned kitchen-cum-stores would be completed by December, 2016.
- Social audit in Baran and Dungarpur would be completed during 2016-17.
- Necessary action would be taken to roll out the automated monitoring system within the prescribed timelines.
