□ 12th Plan ended on 31st March, 2017.

MoF permitted the continuation of Mid Day Meal Scheme till 30th September, 2017 beyond 12th Plan.

- independent evaluation of the scheme
- fresh appraisal/approval of the scheme by EFC/CCEA.
- Evaluation of MDMS has been assigned to two independent agencies.
- Interim report received.



Continuation of MDMS

- Meanwhile MoF has allowed continuation of the scheme till 31st December, 2017-18
- For appraisal of the Scheme by Expenditure Finance Committee (EFC), EFC Memo prepared for implementation of the MDMS during 2017-18, 2018-19 and 2019-20.
- Comments of appraisal agencies obtained on EFC and final EFC submitted to MoF for convening the meeting of EFC

Salient features of EFC



A. Existing Components

- Revision of Cooking cost @ 7.5% annually
- Revision of transportation assistance @ Rs.150 maximum per quintal or actual whichever is less.
- MME @ 3% of recurring central assistance
- Revision of norms for kitchen devices @ Rs.15,000 on an average per school linked to enrolment.
- No change for honorarium to CCH
