**Subject: Revision of cooking cost @ 10.99% w.e.f. 01.04.2020 during 2020-21 under National Programme of Mid Day Meal in Schools (NP-MDMS) -regarding.**

Sir / Madam,

I am directed to say that it has been decided with the approval of the competent authority to increase the cooking cost by 10.99% over and above the existing cooking cost under National Programme of Mid Day Meal in schools w.e.f. 1st April, 2020 for the year 2020-21. The cooking cost will be shared between the Centre and States in the ratio of 60:40 for non-North Eastern Region (NER) States & UTs with legislature (except J & K), 100% for UTs without legislature and 90:10 for NER States, UT with legislature viz. Jammu & Kashmir and 2 Himalayan States viz. Himachal Pradesh, and Uttarakhand. The rates of cooking cost admissible w.e.f. 01.04.2020 during 2020-21 for Primary and Upper Primary classes would be as under:-

2. The above cooking cost rates indicate the minimum mandatory contribution by the State Governments/UT Administrations However' States / UTs may contribute more than their prescribed share, as some States/UTs had been contributing more




than their minimum mandatory share from their own resources for providing meals with augmented nutrition under Mid Day Meal Scheme.

3. You are requested to disseminate the above increase in the cooking cost to all concerned and the field functionaries up to school / cooking agency level to ensure prompt implementation of the revised cooking cost with effect from 01.04.2020
